Total number of local companies in Hong Kong surpasses 1.4 million

The total number of local companies registered under the Companies Ordinance in Hong Kong reached 1,407,743 at the end of June this year, up 23,797 on the figure at the end of 2017, according to the statistics released by the Companies Registry on July 8.

A total of 85,449 local companies were newly registered during the first half of 2018, among which 30,447 were incorporated online via the one-stop electronic company incorporation and business registration service at the e-Registry.

With effect from March 1, all companies incorporated in Hong Kong, except listed companies, are required to maintain up-to-date beneficial ownership information by way of keeping a Significant Controllers Register. The Register should be open for inspection by law enforcement officers upon demand.

Regarding non-Hong Kong companies that have established a place of business in Hong Kong, 592 companies were newly registered under the Companies Ordinance in the first half of 2018, compared to 566 in the second half of 2017. The total number of registered non-Hong Kong companies reached 10,755 by the end of June 2018.

London-based fintech company brings innovative international money transfer platform to Hong Kong

Leading London-based fintech company TransferWise announced on July 6 the official launch of its international money transfer platform in Hong Kong, giving it a major foothold in Asia as part of the company's ongoing international expansion.

TransferWise operates on the concept of matching up transfers with other people on

the digital platform. It uses the mid-market rate, which is only a fraction of the rates used by traditional currency transfer operators. After a successful pilot period, TransferWise said it had already been able to drop prices for customers transferring money from Hong Kong by more than 20 per cent.

Asian Aviation Meteorological Centre commences operation

The Asian Aviation Meteorological Centre (AAMC), jointly established by the Hong Kong Observatory (HKO), the Civil Aviation Administration of China (CAAC) and the China Meteorological Administration (CMA), commenced operation on July 11. The AAMC aims at providing meteorological organisations in the region and the aviation sector with quality en-route weather information, so as to meet industry needs and improve aviation safety and efficiency.

The AAMC will support meteorological organisations in the region in better serving the aviation sector and coping with increasing flight traffic. In 2004, the three agencies established the Asian Aviation Meteorological Service Website, which is the predecessor of the AAMC. Since then, the website has been fully upgraded. The three agencies have also been working closely with meteorological organisations in the region to co-ordinate Significant Weather Information (SIGMET) with a view to improving the level of aviation meteorological services in the region.

The AAMC comprises a main centre operated by the CAAC, a technical support centre operated by CMA, both in Beijing, and a backup centre operated by the HKO in Hong Kong. The HKO's backup centre will specialise in nowcasts and high-resolution numerical weather forecasts, and related verification, as well as objective assessment and verification of forecasts by the main and technical support centres. The backup centre will also support the daily operation of the main centre.
