# The Financial Secretary uses Budget to help diversify economy, and promote innovation and technology

The Financial Secretary of the Hong Kong Special Administrative Region (HKSAR) Government, Mr Paul Chan, in his 2019-20 Budget delivered on February 27 unveiled a raft of initiatives to promote economic development and diversify Hong Kong's economy to enhance competitiveness and overcome challenges posed by changes in the external economy.

Mr Chan said innovation and technology (I&T) development was a priority for Hong Kong, with over HK\$100 billion committed by the current-term Government.

The Financial Secretary proposed a 75 per cent reduction of profits tax, salaries tax and tax under personal assessment for the year of assessment 2018-19, subject to a ceiling of HK\$20,000 per case. This measure will cost the HKSAR Government HK\$18.9 billion, benefiting about 2.05 million taxpayers. The Financial Secretary also proposed to waive the business registration fees for 2019-20.

#### Hong Kong Economic and Trade Office in Bangkok commences operation

The Hong Kong Economic and Trade Office in Bangkok (Bangkok ETO) commenced operation on February 28. The opening of the third Economic and Trade Office established by the HKSAR Government in the Association of Southeast Asian Nations (ASEAN) region is set to further strengthen Hong Kong's economic and trade relations with the region for more new business opportunities.

Addressing the opening ceremony, the Chief Executive of HKSAR Mrs Carrie Lam, said that the establishment of the Bangkok Office is a clear and compelling statement of the importance of the ASEAN to Hong Kong, noting that ASEAN is Hong Kong's second largest trading partner since 2010. Looking ahead, Mrs Lam expected the Bangkok ETO to play the role of facilitator to connect businesses and organisations between Hong Kong and Thailand, and serve as a catalyst to take the cooperation of both sides to new heights and fresh directions. The geographical coverage of the Bangkok ETO includes Thailand, Cambodia, Myanmar and Bangladesh, which is another country with great development potentials. The ETOs in Singapore and Jakarta will continue to cover other countries in the ASEAN region.

During her visit in Bangkok, Mrs Lam met with the Prime Minister, the Deputy Prime Minister and the Minister of Foreign Affairs of Thailand, and attended a business seminar as well as the opening ceremony of cultural collaboration activities between Hong Kong and Thailand.

Noting that the Free Trade Agreement (FTA) between Hong Kong and the ASEAN and the related Investment Agreement were signed in late 2017, Mrs Lam thanked the Thailand Government for the co-ordination role it took throughout the negotiations, as well as its timely ratification of the FTA and its effort to encourage other ASEAN member states to expedite their ratification process. She expressed the hope that Thailand will continue to support the early implementation of the FTA to further enhance trade and economic ties between Hong Kong, Thailand and ASEAN.

#### **CE visits Beijing**

The Chief Executive of HKSAR, Mrs Carrie Lam, visited Beijing from March 1 to 7.

On March 1, Mrs Lam attended the second plenary meeting of the Leading Group for the Development of the Guangdong-Hong Kong-Macao Greater Bay Area (Greater Bay Area) convened by the Vice Premier of the State Council, Mr Han Zheng, at the Great Hall of the People in Beijing.

Mrs Lam welcomed the eight policy measures introduced by the Central Government for taking forward the development of the Greater Bay Area. She said such measures could facilitate Hong Kong residents to develop, work and reside in the Mainland cities of the Greater Bay Area, as well as strengthen the convenient flow of people and goods within the Greater Bay Area.

On March 2, Mrs Lam attended the signing ceremony for the donation by the Ng Teng Fong Charitable Foundation to the Palace Museum and visited the Palace Museum and its exhibition in Beijing. The donation by the Ng Teng Fong Charitable Foundation serves to fund the repair of the Palace of Prolonging Happiness in the Palace Museum,

the establishment of a gallery of foreign artefacts and the restoration of more than 200 foreign artefacts.

On March 4, Mrs Lam met with the Chairman of the China Securities Regulatory Commission (CSRC), Mr Yi Huiman, and the Minister of the National Health Commission (NHC), Mr Ma Xiaowei, in Beijing with the aim of strengthening co-operation with the Mainland in the sectors of finance and medicine and to exchange views on follow-up work in the relevant areas of the Outline Development Plan for the Greater Bay Area.

On March 5, Mrs Lam attended the opening ceremony of the second session of the 13th National People's Congress (NPC) in Beijing. Premier Li Keqiang delivered the government work report in the meeting. Premier Li reviewed the work in 2018 in the government work report and noted that the development plan for the Greater Bay Area will be implemented in 2019, strengthening regulatory interface, fostering efficient flows of factors of production and facilitating personnel exchange. He reiterated in the work report that the Central Government supports Hong Kong in seizing the immense opportunities brought about by the Belt and Road Initiative and the development of the Greater Bay Area and in giving full play to Hong Kong's advantages to fully enhance mutually beneficial co-operation with the Mainland.

Mrs Lam said the HKSAR Government will uphold the "One Country, Two Systems" principle to promote proactively the development of the Greater Bay Area.

On March 6, Mrs Lam visited Tsinghua University and met with the Party Secretary of Tsinghua University, Professor Chen Xu. She delivered a speech to over 300 teachers and students and answered questions from the students. Among those attending the session were dozens of young Hong Kong people studying in Tsinghua University.

#### Japanese companies extend reach to Hong Kong

# Hong Kong residents born in 1985 or 1986 should apply for new smart identity cards on or before March 30

The Immigration Department of the HKSAR Government on March 1 reminded Hong Kong residents born in 1985 or 1986 to apply for a new smart identity card in person at a Smart Identity Card Replacement Centre (SIDCC) on or before March 30. The SIDCCs will be open from Mondays to Saturdays, from 8am to 10pm (except public holidays).

Eligible applicants may also bring along up to two family members or friends aged 65 or above to replace their smart identity cards together during the same visit to an SIDCC.

If eligible applicants are absent from Hong Kong during their call-up period, they can apply within 30 days of their return to Hong Kong.

#### **Recruitment of qualified doctors outside Hong Kong**

The Hospital Authority (HA) on March 6 announced that confirmation has been received from the Medical Council of Hong Kong on the approval of three new applications of non-locally trained doctors for practice with Limited Registration in public hospitals to help relieve the front-line workload. The three doctors will be serving in Radiology, Emergency Medicine and Family Medicine.

At the moment, there are 16 non-locally trained doctors who have been assessed to be eligible for the recruitment exercise and considered suitable for appointment after interviews by user departments. As at January 2019, there are 10 non-locally trained doctors working in public hospitals to relieve the manpower pressure in the respective units in the specialties of Anaesthesia, Cardiothoracic Surgery, Emergency Medicine, Family Medicine and Internal Medicine.
