## Applications for Hong Kong civil service posts

Prospective applicants for Hong Kong civil service posts at degree or professional level can now apply to sit the Common Recruitment Examination and Basic Law Test (CRE and BLT) scheduled to be held on **June 1 and 8, 2019 in Hong Kong**. The deadline for application is **April 11, 2019 (Hong Kong time)**.

Valid CRE results are required of applicants for civil service posts at degree or professional level, unless applicants possess equivalent results in the Hong Kong Diploma of Secondary Education Examination or other specified public examinations. Persons interested in applying for civil service posts at degree or professional level in the near future may wish to consider sitting the coming examination so as to be eligible to apply for these posts, which may become available before another CRE is held.

In addition, applicants for civil service posts will be assessed on their Basic Law knowledge. The result of the BLT will be one of the considerations to assess the suitability of a candidate.

Another round of the CRE and BLT will be held in late 2019. For the convenience of those studying or residing outside Hong Kong, this round of examination will also be held in some non-local cities. The examination is tentatively scheduled for October 5 and 12, 2019 in Hong Kong, and **December 7, 2019 in non-local cities**. Details relating to this round of examination will be announced later this year.

#### CE attends Boao Forum for Asia Annual Conference in Hainan

The Chief Executive of the Hong Kong Special Administration Region (HKSAR), Mrs Carrie Lam, on March 28 attended the opening ceremony of the Boao Forum for Asia Annual Conference 2019 in Hainan and met with central ministry, province and city leaders.

The Premier of the State Council, Mr Li Keqiang, delivered the keynote speech at the opening ceremony themed "Shared Future, Concerted Action, Common Development". He said that the country would broaden market access for investment from Hong Kong, Macao and Taiwan; open sectors such as finance, professional services and high-end manufacturing wider; and continue to roll out policy initiatives to facilitate the movement of Hong Kong, Macao and Mainland people as well as the flow of factors of production. Mrs Lam said these measures will be welcomed by Hong Kong enterprises and various professional sectors and show once again the Central Government's support for the HKSAR.

Mrs Lam joined the Women Roundtable themed "The Power of Women and the Value of Balance" to discuss with outstanding women leaders from around the world, women's potential and the promotion of women's development and a thematic dinner hosted by the Boao Forum for Asia.

On March 29, Mrs Lam addressed the "ASEAN-China Governors/Mayors' Dialogue" session at the Boao Forum. She told the participants about the pivotal role Hong Kong can play in strengthening connections between Mainland China and the Association of Southeast Asian Nations (ASEAN). She said that Hong Kong set up in Bangkok its third Economic and Trade Office in ASEAN in February and the ratification of its Free Trade Agreement signed with ASEAN at the end of 2017 is making good progress. She expressed the hope that Hong Kong can go further by joining the Regional Comprehensive Economic Partnership in due course, creating a bigger economic pie for Hong Kong, ASEAN and related signatory states.

HKSAR and Mainland sign arrangement on interim measures in aid of arbitral proceedings

The Secretary for Justice of the HKSAR, Ms Teresa Cheng, SC, and the Vice-president of the Supreme People's Court, Mr Yang Wanming, signed the Arrangement Concerning Mutual Assistance in Court-ordered Interim Measures in Aid of Arbitral Proceedings by the Courts of the Mainland and of the HKSAR (Arrangement) on April 2. Hong Kong becomes the first jurisdiction outside the Mainland where, as a seat of arbitration, parties to arbitral proceedings administered by its arbitral institutions would be able to apply to the Mainland courts for interim measures.

Under existing Hong Kong legislation, parties to arbitral proceedings in any place may apply to the courts of Hong Kong for interim measures. After the commencement of the Arrangement, parties to arbitral proceedings in Hong Kong, before the arbitral award is made, can make an application for interim measure to the Mainland courts, including property preservation, evidence preservation and conduct preservation. It aims at preventing one of the parties to arbitral proceedings from deliberately destroying the evidence or transferring the property and also ensuring that the arbitral proceedings can be carried out effectively.

The commencement date of the Arrangement will be decided after the promulgation of a judicial interpretation by the Supreme People's Court and completion of relevant procedures in the HKSAR.

# InvestHK encourages Zhejiang companies to leverage Hong Kong's international financing platform to "go global"

Invest Hong Kong (InvestHK) hosted a seminar in Hangzhou, Zhejiang Province on April 2 encouraging Zhejiang enterprises to make use of Hong Kong's international financing platform and its business advantages in the Belt and Road Initiative and the Guangdong-Hong Kong-Macao Greater Bay Area development to accelerate their overseas expansion.

Speaking at the seminar entitled "Leveraging Hong Kong's international financing platform for Zhejiang enterprises to 'go global'", the Director-General of Investment Promotion, Mr Stephen Phillips, told the audience about the new business opportunities Hong Kong has to offer as an international business platform in the context of the Belt and Road Initiative and the Guangdong-Hong Kong-Macao Greater Bay Area development. He added that the Central Government recently announced the Outline Development Plan for the Guangdong-Hong Kong-Macao Greater Bay Area. Hong Kong's contributions within the Greater Bay Area are unique. As the most international city in the Greater Bay Area, Hong Kong will continue to play a role as a gateway for multinational companies accessing the Mainland market and as a springboard for Mainland companies seeking to "go global".

## Hong Kong Customs seizes suspected cannabis buds

Hong Kong Customs inspected a parcel from Canada and seized about 2 kilograms of suspected cannabis buds with an estimated market value of about HK\$510,000 at Hong Kong International Airport on March 18. After follow-up investigation, Customs officers on March 26 arrested a 28-year-old man suspected to be connected to the case.

Under the Dangerous Drugs Ordinance, trafficking in a dangerous drug is a serious offence. The maximum penalty upon conviction is a fine of HK\$5 million and life imprisonment.

Customs also issued a reminder that cannabis and tetrahydro-cannabinol (THC) are classified as dangerous drugs under the Ordinance. Importation of products (including food and drinks) containing cannabis or THC into Hong Kong is prohibited unless the relevant provisions in the Ordinance are complied with. In order to avoid breaching the law inadvertently, special attention should be paid to the packaging labels of food and drinks.
