### Agreements between Hong Kong and ASEAN enters into force

A spokesman from the Hong Kong Special Administrative Region (HKSAR) Government announced on May 9 and 11, that the commitments made under the Free Trade Agreement (FTA) between Hong Kong and the Association of Southeast Asian Nations (ASEAN) among Hong Kong and five ASEAN member states, namely Myanmar, Singapore, Thailand, Laos and Vietnam will enter into force on June 11.

Upon the implementation of the FTA, on trade in goods, Singapore commits to binding all its customs duties at zero, whereas Myanmar, Thailand, Laos and Vietnam will progressively eliminate and reduce their customs duties on goods originating from Hong Kong. The tariff reduction commitments cover different kinds of Hong Kong commodities, including jewellery, articles of apparel and clothing accessories, watches and clocks and toys.

On trade in services, upon the implementation of the FTA and in respect of Myanmar, Singapore, Thailand, Laos and Vietnam, Hong Kong service providers will enjoy better business opportunities and legal certainty in market access for a comprehensive range of services sectors. These include professional services, business services,

telecommunications services, construction and related engineering services, educational services, financial services, tourism and travel related services, transport services and arbitration services.

In addition, the spokesman said on May 16 that those parts relating to Hong Kong and five Association of Southeast Asian Nations (ASEAN) member states, namely Laos, Myanmar, Singapore, Thailand and Vietnam, under the Investment Agreement (IA) between Hong Kong and ASEAN, will enter into force on June 17.

Upon the entry into force of the IA, Laos, Myanmar, Singapore, Thailand and Vietnam will provide Hong Kong enterprises investing in their areas with fair and equitable treatment of their investments, physical protection and security of their investments, and the assurance on the free transfer of their investments and returns. In case of expropriation or investment loss owing to war, armed conflict or similar events, the above-mentioned five ASEAN member states will also provide compensation to Hong Kong enterprises investing in their areas according to the agreed standard as specified under the IA.

ASEAN comprises 10 member states, namely Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand and Vietnam. Hong Kong and ASEAN signed the FTA and an IA at the end of 2017.

The dates of entry into force for the remaining five ASEAN member states (Brunei Darussalam, Cambodia, Indonesia, Malaysia and the Philippines) will be announced as soon as they are confirmed.

## **SCED attends APEC and OECD meetings**

The Secretary for Commerce and Economic Development of the HKSAR Government, Mr Edward Yau, attended the Asia-Pacific Economic Cooperation (APEC) Ministers Responsible for Trade (MRT) Meeting held in Chile, and will join the Ministerial Council Meeting (MCM) of the Organisation for Economic Co-operation and Development (OECD) and the World Trade Organization (WTO) Informal Ministerial Gathering in France from May 22 to 23.

Mr Yau first attended the APEC MRT Meeting in Vina del Mar, Chile on May 17. APEC 2019 is themed "Connecting People, Building the Future". Mr Yau joined discussion

sessions with ministers of other member economies on topics including APEC and the WTO, advancing APEC's regional economic integration agenda, and strengthening inclusive and sustainable growth in the digital era. On the sidelines of the MRT Meeting, he signed an Investment Promotion and Protection Agreement between Hong Kong and Mexico, and met with other participating ministers for exchanges on bilateral trade and economic relations as well as issues of mutual concern.

On the margins of the APEC MRT, Mr Yau took the opportunity to hold bilateral meetings with the Federal Minister of International Trade Diversification of Canada, Mr James Carr; the Deputy Minister of Economic Development of the Russian Federation, Mr Timur Igorevich Maximov; and the Assistant Minister of Commerce, Mr Li Chenggang. They had useful exchanges on bilateral trade and economic relations and issues of mutual concern.

After attending the APEC meetings, Mr Yau visited London, the UK from May 20 to 21. He met with senior government officials and parliamentarians to explore further cooperation on bilateral trade and creative industries development. He delivered a keynote speech at a seminar on Hong Kong creative industries and design, and spoke on Hong Kong's latest economic and trade situation as well as its role in the development of the Guangdong-Hong Kong-Macao Greater Bay Area and the Belt and Road Initiative at a roundtable discussion at Asia House. He encouraged British enterprises to leverage on Hong Kong's unique advantages to tap into the opportunities brought by the Belt and Road Initiative and the Guangdong-Hong Kong-Macao Greater Bay Area (Greater Bay Area) development.

Mr Yau will then attend the MCM of the OECD in Paris, France from May 22 to 23. He will attend a ministerial dinner hosted by the Slovak Republic, the Chair of the 2019 MCM, and join a session on digital trade where participating ministers will discuss the impact of digitalisation on trade. On the margins of the MCM, Mr Yau will attend the WTO Informal Ministerial Gathering to discuss issues relating to WTO reform and achievable outcomes for the 12th WTO Ministerial Conference next year.

Mr Yau will return to Hong Kong on May 24.

## **Granting of virtual banking licences**

The Hong Kong Monetary Authority (HKMA) announced on May 9 that the Monetary Authority has granted banking licences under the Banking Ordinance to Ant SME Services (Hong Kong) Limited, Infinium Limited, Insight Fintech HK Limited and Ping An OneConnect Company Limited for them to operate in the form of a virtual bank. The granting of these banking licences takes effect the same day. According to their business plans, these four newly licenced virtual banks intend to launch their services in around six to nine months.

HKMA said the launch of virtual banks in Hong Kong, which is a key component of the Smart Banking Initiatives, will certainly facilitate financial innovation, enhanced customer experience and financial inclusion.

After the granting of the above banking licences, the number of licensed banks in Hong Kong increases to 160.

# Application for Next Generation HKSAR e-Passport and e-Doc/I start from May 14

The Immigration Department (ImmD) of the HKSAR Government announced on May 9 that it will start to accept applications for the Next Generation HKSAR Electronic Passport (e-Passport) and Electronic Document of Identity for Visa Purposes (e-Doc/I) from May 14 onwards. The time required for processing such applications will be shortened from 10 to five working days.

The new e-Passport and e-Doc/I will continue to be produced in compliance with the standard of the International Civil Aviation Organization, with the holder's personal data and facial image stored in digital form in the contactless chip embedded in the back cover of the documents. Meanwhile, the security features of the new documents will be further enhanced.

To further enhance the service standards, the ImmD has provided additional means for submitting e-Passport applications. Apart from the existing application means, eligible applicants can also submit applications through the ImmD Mobile App.
