HKSAR Government's response to public processions against legislative proposal

The Hong Kong Special Administrative Region (HKSAR) Government responded to the public processions against the proposed legislative amendments to extradition laws held in Hong Kong on June 9 and 16.

Over the past two Sundays, a large number of people have expressed their views during public processions. The Government understands that these views have been made out of love and care for Hong Kong.

The Chief Executive clearly heard the views expressed in a peaceful and rational manner. She acknowledged that this embodied the spirit of Hong Kong as a civilised, free, open and pluralistic society that values mutual respect, harmony and diversity. The Government also respects and treasures these core values of Hong Kong.

Having regard to the strong and different views in society, the Government has suspended the legislative amendment exercise at the full Legislative Council with a view to restoring calmness in society as soon as possible and avoiding any injuries to any persons. The Government reiterated that there is no timetable for restarting the process.

The Chief Executive admitted that the deficiencies in the Government's work had led to substantial controversies and disputes in society, causing disappointment and grief among the people. The Chief Executive apologised to the people of Hong Kong for this and pledged to adopt a most sincere and humble attitude to accept criticisms and make improvements in serving the public.

SCED visits United States

The Secretary for Commerce and Economic Development of the HKSAR Government, Mr Edward Yau, visited New York and Washington, DC, in the United States (US) between June 10 and 12 to consolidate and strengthen economic ties between Hong Kong and the US.

We work across Canada

On June 10, Mr Yau met key people in the financial, business, legal and academic sectors in New York at a roundtable breakfast meeting. He updated participants on the latest economic development of Hong Kong and had useful exchanges with them on Hong Kong-US bilateral relations and the current state of international trade. He stressed that the unique strengths of Hong Kong are guaranteed under the Basic Law and that Hong Kong will endeavour to safeguard core values which are key to Hong Kong's continued success, including the rule of law and open and free markets.

Mr Yau then proceeded to Washington, DC and attended a reception in celebration of the 50th anniversary of the American Chamber of Commerce in Hong Kong. At the reception, Mr Yau said Hong Kong has long been a preferred platform for American companies seeking to establish or expand their business in the Mainland of China or throughout the Asia-Pacific region. Over the past 50 years bilateral relationship between Hong Kong and the US has gone from strength to strength, noting that during this period trade between the two economies has mushroomed, growing from roughly US\$8 billion to US\$70 billion.

On the next day, Mr Yau had a breakfast meeting with the former US Secretary of Commerce, Mr Carlos Gutierrez, before meeting with some US congressional members. Mr Yau also had a lunch meeting with senior members of the Heritage Foundation, including its founder, Dr Edwin Feulner. He welcomed the Foundation's high regard for Hong Kong as the world's freest economy for 25 consecutive years, which he said reaffirmed the Government's steadfast commitment in upholding free market principles over the years.

At a reception hosted by the Hong Kong Economic and Trade Office, Washington, DC (Washington ETO) for US government officials, think tank members, academics, and leaders of chambers of commerce and business organisations, Mr Yau said that the trade and economic relationship between Hong Kong and the US is mutually beneficial and expanding. He said Hong Kong will continue to explore ways to deepen and broaden its links with the US in areas such as collaborations in innovation and technology and educational, scientific and medical exchanges.

On June 12, Mr Yau attended the luncheon co-organised by Washington ETO and the Brookings Institution. Mr Yau shared his insights on the state of free trade from Hong Kong's perspective with about 60 US business and academic leaders. He said that Hong Kong vigorously pursues a free trade policy and firmly believes in multilateral trading system. Hong Kong and like-minded economies are pressing ahead to forge alliances through the signing of free trade agreements (FTAs). In this regard, the latest addition to Hong Kong's FTA portfolio is a high quality and comprehensive in scope FTA, and an investment agreement with Australia signed in March.

Hong Kong and United Arab Emirates sign Investment Promotion and Protection Agreement

Hong Kong and the United Arab Emirates (UAE) signed an Investment Promotion and Protection Agreement (IPPA) on June 16 to strengthen mutual investment protection. The Agreement seeks to enhance the confidence of investors, expand investment flows and further strengthen the economic and trade ties between the two places.

Under the Agreement, the two governments undertake to provide investors of the other side with fair, equitable and non-discriminatory treatment of their investments; compensation in the event of expropriation of investments; and the right to free transfers abroad of investments and returns. The Agreement also provides for settlement of investment disputes under internationally accepted rules. The Agreement will enter into force after the fulfillment of relevant internal requirements by both sides.

The IPPA with the UAE is the third similar agreement that this term of the HKSAR Government has signed since taking office in July 2017; the other two are the investment agreements with the Association of Southeast Asian Nations and Australia respectively. Hong Kong has signed investment agreements with 21 foreign economies including Canada.
