### Government response to violent protests

In response to the protests and violent activities in the last two weeks, the Hong Kong Special Administrative Region (HKSAR) Government issued solemn statements condemning the acts of the violent protesters who vandalised public property, blocked roads, paralysed airport operation causing serious disruption to inbound and outbound travelers, besieged police stations, aimed laser beams and hurled bricks to attack police officers. Some violent protesters even hurled petrol bombs, injuring a police officer. The HKSAR Government is outraged by the violent protesters' behaviours which showed a total disregard of the law, posing a serious threat to the safety of police officers and other members of the public.

The HKSAR Government appeals to all members of the public to say no to violence to help the community to restore order as soon as possible. The Police will enforce the law strictly and resolutely to bring illegal protesters to justice.

The Financial Secretary of the HKSAR Government, Mr Paul Chan, said in a press conference held on August 7 that Hong Kong's second quarter economic data indicated, on a quarter-to-quarter basis, the GDP has decelerated in the second quarter and come down to negative 0.3 per cent. The economic situation, both externally and domestically was challenging in July. Hong Kong is struggling with its social issues and there are increasing external uncertainties caused by escalating US-China trade conflict as well as other geo-political situations.

### **Phone call between CE and the Foreign Secretary of the United Kingdom**

In response to media enquiries on the phone call between the Chief Executive of the HKSAR, Mrs Carrie Lam and the Foreign Secretary of the United Kingdom, Mr Dominic Raab on August 9, the Chief Executive's Office said that at the request of the British Consulate-General Hong Kong, Mrs Lam spoke with the new Foreign Secretary of the UK, Mr Raab over the phone. During the 20-odd minutes of conversation, Mrs Lam stressed that since Hong Kong's return to the Motherland, "One Country, Two Systems" has been successfully implemented in the HKSAR and that the rule of law has been the core value of the city.

Mrs Lam introduced to Mr Raab the background and objectives of the legislative amendment exercise and emphasised that the legislative amendment exercise was put to a complete stop two months ago. She said that while the HKSAR Government respects the diverse views held by members of the public on various issues as well as the freedoms of speech and assembly, it will not let violence and illegal behaviours disrupt public order. She also mentioned to Mr Raab the work being done by the Independent Police Complaints Council in accordance with its statutory functions.

Mrs Lam pointed out at the end that she and the relevant policy bureaux have been attaching great importance to collaboration between Hong Kong and the UK on areas including trade, economic affairs and culture in the past two years and expressed the hope that bilateral relations can be further strengthened.

### **InvestHK encourages Shandong companies to leverage Hong Kong's business advantages and professional services to "go global"**

Invest Hong Kong (InvestHK) of the HKSAR Government held an investment promotion seminar in Jinan, Shandong Province, on August 7 to encourage Shandong enterprises to make use of Hong Kong's business advantages and professional services to accelerate their overseas expansion amid the Belt and Road Initiative and the Guangdong-Hong Kong-Macao Greater Bay Area development.

The seminar, entitled "Leveraging Hong Kong's platform for Shandong enterprises to 'go global'", was jointly organised by InvestHK and the Department of Commerce of Shandong Province. It was also co-organised by the Hong Kong Economic and Trade Office in Shanghai and the Shandong Liaison Unit of the HKSAR Government. The Associate Director-General of Investment Promotion, Dr Jimmy Chiang, and the Deputy Director of Department of Commerce of Shandong Province, Mr Zhang Weike, delivered welcome remarks at the event.

Dr Chiang said that operating under the principle of "one country, two systems", Hong Kong enjoys the dual advantages of being part of China, while maintaining its international outlook and role as an international centre for professional services, finance, transportation and trade, with its own economic, legal and social systems. With the aim of upgrading its industrial transformation, Shandong enterprises can leverage Hong Kong's vibrant business platform to seize the new opportunities arising from the Belt and Road Initiative and the Guangdong-Hong Kong-Macao Greater Bay Area development.

### **Visa-free access to Iran for HKSAR passport holders**

The HKSAR Government has received confirmation from the Government of Iran that with immediate effect HKSAR passport holders may visit Iran visa-free for a stay of up to 21 days.

The Immigration Department of the HKSAR Government said that Iran is along the Belt and Road. Under the Belt and Road Initiative, this visa-free arrangement would bring greater travel convenience to the travellers of Hong Kong and strengthen the tourism, cultural and economic ties between the two places.

- You want to be alerted as soon as your property is subjected to or may be affected by potential or actual disputes.
