# CE announces withdrawal of Fugitive Offenders Bill among "four actions" to help society move forward

The Chief Executive of the Hong Kong Special Administrative Region (HKSAR), Mrs Carrie Lam, announced on September 4 that the HKSAR Government will "formally withdraw" the Fugitive Offenders Bill (the Bill). The decision to withdraw the Bill is one of "four actions" announced by Mrs Lam to foster dialogue that can help society move forward after more than two months of social unrest.

This first action is to fully allay public concerns. The Secretary for Security will announce in the Legislative Council (LegCo) that the Bill will be withdrawn when the LegCo resumes, and there will be no debate or voting.

The second action is that the Government will fully support the work of the Independent Police Complaints Council (IPCC). IPCC announced on September 5 details of the members of a panel of international experts, which will help in the assessment and recommendations in the fact-finding study. These international experts are renowned experts in their respective fields and they come from the United Kingdom, Canada, Australia and New Zealand. In addition to overseas experts, the CE has appointed two new members to the IPCC and pledged that the Government will seriously follow up recommendations made in the IPCC's report.

The third action is that the CE and Principal Officials will reach out to the community to start a direct dialogue. People from all walks of life, with different stances and backgrounds, are invited to share their views and air their grievances. The Government must find ways to address the discontent in society and look for solutions.

The fourth action is that the Government will invite community leaders, professionals and academics to independently examine and review society's deep-seated problems and to advise the Government on finding solutions. After more than two months of social unrest, it is obvious to many that discontentment extends far beyond the Bill, covering political, economic and social issues.

Mrs Lam said the use of violence will never be a solution and that lingering violence is damaging the very foundations of our society, especially the rule of law. Some people, though not many, attacked the Central Government's office in Hong Kong and vandalised the national flag and national emblem. This is a challenge to "One Country, Two Systems".

The HKSAR Government's foremost priority now is to end violence, to safeguard the rule of law and to restore order and safety in society. It will continue to strictly enforce the law against all violent and illegal acts.

Mrs Lam said the four actions announced are her Government's sincere and solemn response to the five demands that have been raised by the public.

# Seventh meeting of Chief Executive's Council of Advisers on Innovation and Strategic Development held

The Chief Executive's Council of Advisers on Innovation and Strategic Development (the Council) held its seventh meeting on September 3 to exchange views on the current situation of Hong Kong. Members also gave their views on the broad directions of the 2019 Policy Address.

At the meeting, members were briefed on the recent performance and near-term outlook of the Hong Kong economy. In view of the gloomy economic outlook and the negative impact of the recent social incidents, Members deliberated on measures to safeguard the stability of the Hong Kong economy.

Members also gave views and suggestions on the focuses of the 2019 Policy Address. They generally felt that, to address the challenges faced by Hong Kong, bold policies and effective measures should be taken forward to support the economy, improve people's livelihood, and rebuild Hong Kong's international image.

#### Government condemns offenders' violent and vandalistic acts

In response to the violent and vandalistic acts of radical protesters in various districts on Hong Kong Island and in Kowloon as well as at the Hong Kong International Airport and MTR stations in the last two weeks, the HKSAR Government said that some radical protesters attacked the police stations, extensively vandalised public property and MTR stations, and set fires at various places, totally disregarding law and order. The behaviours are outrageous. The offenders breached the public peace and their acts seriously affected public services, disregarding the needs and rights of other members of the public. Also it is extremely dangerous to set fires in busy areas, jeopardising people's safety. The HKSAR Government severely condemns the offenders' violent and vandalistic acts. The Police will take resolute enforcement actions to protect the safety and rights of the members of the public.

In addition, the HKSAR Government expresses gratitude to the Police, the Airport Authority Hong Kong, the MTR Corporation, the aviation sector and public officers of relevant departments for standing fast at their posts and doing their best to work together, enabling the largely smooth operation of the railway and the airport, the two major infrastructure projects, with efficient services continued to be provided to millions of travellers and members of the public. The court has already granted separate injunction orders to restrain people from obstructing the operation of the airport and railway. The HKSAR Government appeals to members of the public to abide by the law and take into account the rights and the needs of travellers and other members of the public when expressing their views.

# CEDB holds SME Symposium titled "New measures in facing economic downturn"

To provide effective support and assistance to small and medium enterprises (SMEs), the Commerce and Economic Development Bureau of the HKSAR Government held a

symposium for SMEs titled "New measures in facing economic downturn" on September 4, providing an overview of various government funding schemes and new support measures for SMEs. The symposium was attended by more than 300 SME representatives.

The symposium comprised three panel sessions with the themes of "Exploring New Markets and Opportunities", "Financing Strategies for SMEs" and "Technological Application and Upgrading".

The Secretary for Commerce and Economic Development (SCED), Mr Edward Yau, said at the symposium that a lot of funding schemes have been set up by the Government and non-government organisations to provide enterprises and relevant organisations with all-round support on exploring export markets, obtaining financing, application of technology, recruiting professionals and more. The Government will enhance the utilisation and effectiveness of these funding schemes through raising awareness, implementing facilitation measures, as well as capital injections. The Government will also stay alert to the needs and difficulties of SMEs, and continue to review and improve the existing funding schemes.

# SCED: Free Trade Agreement with ASEAN important pillar for further collaboration

SCED, Mr Edward Yau, attended the 3rd ASEAN Economic Ministers - Hong Kong, China Consultations meeting in Bangkok, Thailand on September 9.

Mr Yau said at the meeting that the Free Trade Agreement (FTA) and the Investment Agreement (IA) between Hong Kong and the Association of Southeast Asian Nations (ASEAN), providing certainty and clarity needed by businesses, will be an important pillar to support further economic collaboration. It also sends a very positive signal to the outside world on the mutual commitment to continued open and free trade and investment.

Hong Kong and ASEAN signed the FTA and IA in November 2017, with the parts relating to Hong Kong and Laos, Myanmar, Singapore, Thailand and Vietnam entering into force in June this year.

# HKSAR and High People's Court of Guangdong Province sign framework arrangement on legal exchange and mutual learning

The Secretary for Justice of the HKSAR Government, Ms Teresa Cheng, SC, signed a framework arrangement with the President of the High People's Court of Guangdong Province, Mr Gong Jiali, on exchange and mutual learning in legal aspects between Hong Kong and Guangdong (the Arrangement) in Shenzhen on September 7 to strengthen legal exchange and collaboration in the Greater Bay Area.

The Arrangement will facilitate courts in Guangdong and relevant legal bodies in Hong Kong to launch projects on legal aspects for mutual exchanges and collaboration to enhance the legal development and safeguard in the Greater Bay Area.

Ms Cheng also attended a seminar organised by the Department of Justice, the High People's Court of Guangdong Province and the Shenzhen Intermediate People's Court under the Arrangement. The seminar gathered Mainland judges to discuss the development of judicial scrutiny of arbitral awards.

# Visa-free access to Myanmar for HKSAR passport holders

The HKSAR Government has received notification from Myanmar that the Tourist Visa Exemption Pilot Scheme of Myanmar was extended for one year until September 30, 2020. Under the Scheme, holders of an HKSAR passport do not need a visa for visiting Myanmar for a stay of up to 30 days.

Myanmar is along the Belt and Road. Under the Belt and Road Initiative, the extension of the Tourist Visa Exemption Pilot Scheme would bring greater travel convenience to Hong Kong travellers and strengthen the tourism, cultural and economic ties between the two places.

Including Myanmar, 166 countries and territories including Canada have granted visafree access or visa-on-arrival to HKSAR passport holders. Please visit the following website for details:
