HKSAR Government introduces anti-mask law

With effect from October 5, the HKSAR Government has put in place the Prohibition on Face Covering Regulation to ban the use of facial covering in public meetings and processions regulated under the Public Order Ordinance (Cap. 245) and unlawful and unauthorised assemblies as well as riots. Offenders will be liable to a maximum fine of \$25,000 and imprisonment for one year.

Making the announcement at a press conference, the Chief Executive of the HKSAR Mrs Carrie Lam said the current situation in Hong Kong has given rise to a state of serious public danger that the HKSAR Government has to address. She said that the Government is particularly concerned that many students are participating in these violent protests or even riots, jeopardising their safety and even their future. A responsible Government has the duty to use all available means in order to stop the escalating violence and restore calmness in society.

The Chief Executive in Council decided at a special meeting on October 4 to invoke the power under the Emergency Regulations Ordinance and make a new regulation in the name of Prohibition on Face Covering Regulation.

Mrs Lam said the regulation is essentially an anti-mask law which has already been introduced in jurisdictions around the world. It is believed that the new law will create a deterrent effect against masked violent protesters and rioters and will assist Police in their law enforcement. She emphasised that the decision to invoke the Emergency Regulations Ordinance is a difficult but also a necessary one for public interest.

Mrs Lam added that she and her Principal Officials will continue the dialogue with the public as it is the best way to find solutions to some of the city's deep-seated social problems and allow Hong Kong to move forward.

Government severely condemns violent acts of masked rioters

Members of the public participated in unauthorised assemblies and processions in various districts on Hong Kong Island and in Kowloon over last two weeks, where a large number of masked rioters took the opportunities to block roads and vandalise public property, MTR stations as well as banks and shops selected by the rioters in various areas. The HKSAR Government severely condemns these violent acts which totally disregard law and order.

A spokesman said that the violent acts in recent days have thrown the community into panic and chaos, affecting public services and prompting malls and shops to suspend businesses for fear of vandalism.

The Prohibition on Face Covering Regulation has come into effect. The HKSAR Government urges the public not to involve in any potential law violation. Police reiterate that no violent behavior will be tolerated. Police will continue to take resolute enforcement action so as to safeguard the city's public safety and bring all lawbreakers to justice. The Government also appeals to members of the public to pay attention to personal safety.

SFST signs CDTA with Estonia in Tallinn

The Secretary for Financial Services and the Treasury, Mr James Lau, signed in Tallinn, Estonia on September 25 a comprehensive avoidance of double taxation agreement (CDTA) with the Minister of Finance of Estonia, Mr Martin Helme, signifying the Government's sustained efforts in expanding Hong Kong's tax treaty network.

This is the 42nd CDTA that Hong Kong has signed with its trading partners, including Canada. The CDTA will reinforce economic and trade connections between the two places, and offer additional incentives for the business sector of both sides to do business or invest.

Under the CDTA, any Estonian tax paid by Hong Kong residents in respect of income derived from sources in Estonia will be allowed as a credit against the Hong Kong tax payable on the same income, subject to the provisions of the tax laws of Hong Kong. For Estonian residents, double taxation will be avoided by way of exemption of the income taxed in Hong Kong from the Estonian tax, or deduction of Hong Kong tax paid from the Estonian tax in respect of the same income. In addition, the CDTA also provides some tax relief arrangements.

Orders on Comprehensive Avoidance of Double Taxation Agreement with Cambodia and Protocol to Comprehensive Avoidance of Double Taxation Arrangement with the Mainland gazetted

Two orders made by the Chief Executive in Council under the Inland Revenue Ordinance (Cap. 112) to implement the Comprehensive Avoidance of Double Taxation Agreement with Cambodia (Cambodia CDTA) and the Fifth Protocol to the Comprehensive Avoidance of Double Taxation Arrangement with the Mainland (Mainland CDTA) respectively were gazetted on October 4.

Under the Cambodia CDTA, investors will not have to pay tax twice on a single source of income. It will bring tax savings and a greater certainty on taxation liabilities for the

residents of the treaty partners when they engage in cross-border trade and investment activities.

Regarding the Fifth Protocol to the Mainland CDTA, it incorporates into the Mainland CDTA a new teachers and researchers article to provide tax relief to qualified Hong Kong and Mainland teachers and researchers working on the other side, as well as measures to prevent tax treaty abuse to ensure that the Mainland CDTA follows the latest international tax standard.
