Currently, except for Hong Kong residents, all travellers arriving Hong Kong by flights from overseas countries/territories will be denied entry. The same restriction also applies to non-Hong Kong residents travelling to Hong Kong from the Mainland of China, Macao and Taiwan who have been to any overseas countries/territories in the past 14 days. These temporary restrictions will remain in force until further notice. Please refer to the webpage https://www.coronavirus.gov.hk/eng/inbound-travel.html for details.

In addition, travellers from Canada are required to present test report, in English or Chinese, showing a negative COVID-19 nucleic acid test administered within 72 hours of the scheduled time of departure, before boarding the flight. They are required to present documentary proof in English to show that the laboratory or healthcare institution is recognized/ approved/ ISO15189 accredited. The same requirements apply to a Hong Kong resident who has stayed in Canada during the 21 days before boarding the flight to Hong Kong. Hong Kong rises one place in Global Financial Centres Index

Hong Kong was ranked fourth in the Global Financial Centres Index (GFCI) 29 Report published on March 17 by the Z/Yen from the United Kingdom and the China Development Institute from Shenzhen.

A spokesman from the Hong Kong Special Administrative Region (HKSAR) Government said that Hong Kong is one of the top four leading financial centres in the world, rising by one place from the September issue of the index last year. Among the five areas of competitiveness, including Business Environment, Human Capital, Infrastructure, Financial Sector Development, and Reputational and General which were formulated based on data, Hong Kong was ranked top five in all these areas.

Hong Kong's financial system has been operating smoothly despite the evolving situation of the COVID-19 pandemic, coupled with other uncertainties in the global environment. Hong Kong's markets are highly open and internationalised, with robust infrastructure support, internationally aligned regulatory regimes, rule of law, a large pool of financial talents and a full range of financial products as well as free flow of information and capital. These competitive edges will continue to consolidate Hong Kong's status as a leading international financial centre.

The GFCI Report is released in March and September every year since 2007. In GFCI 29, 114 financial centres were assessed. Hong Kong came fourth with an overall rating of 741.

Government extends social distancing measures under Prevention and Control of Disease Ordinance

The HKSAR Government gazetted the directions and specifications under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F), the Prevention and Control of Disease (Prohibition on Group Gathering) Regulation (Cap. 599G) and the Prevention and Control of Disease (Wearing of Mask) Regulation (Cap. 599I) to maintain the social distancing measures already in place, and strengthen infection control measures in catering business premises. The directions and specifications will take effect till March 31, 2021.

A spokesman for the Food and Health Bureau said that taking into account the latest public health risk assessment, there is still no room for further relaxation of measures at this stage. The Government will continue to maintain most of the existing requirements and restrictions applicable to catering business premises and scheduled premises, as well as the requirements for group gatherings and mask wearing until March 31.

In addition, the relevant departments have been actively discussing with the industry to encourage fitness centres to enhance infection control measures on a voluntary basis. Such measures include limiting the number of customers in the premises and exploring more frequent tests of staff.

Besides, the HKSAR Government announced on March 15 that in view of the continued severe global epidemic situation of COVID-19, it will maintain the measure under the Prevention and Control of Disease (Regulation of Cross-boundary Conveyances and Travellers) Regulation (Cap. 599H) to restrict persons who have stayed in the extremely high-risk Group A specified places (i.e. Brazil, Ireland, South Africa and the United Kingdom) for more than two hours on the day of boarding or during the 21 days before that day from boarding flights for Hong Kong.

For the very high-risk Group B specified places (including Canada) and the medium to high-risk Group C specified places, as required under the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Cap. 599C) and the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places Regulation (Cap. 599E), all persons arriving at Hong Kong (either via the airport or land boundary control points) who have stayed in places outside China on the day of arrival in Hong Kong or during the 21 days before that day have to undergo compulsory quarantine for 21 days in designated quarantine hotels. For persons arriving at Hong Kong who have stayed in Group B specified places, they also have to present prior to boarding proof of a negative result of a nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft.

Meanwhile, the HKSAR Government announced on March 19 the list of designated quarantine hotels for the third cycle under the Designated Quarantine Hotel Scheme. A total of 30 hotels will provide about 8 300 rooms in the new cycle, with the contract period running from April 21 to June 19.

The HKSAR Government will continue to provide more hotels offering lower room rates in this new cycle. The number of hotels offering room rates at HK\$500 or below will increase from 11 to 13 to provide more than 2 800 rooms. This represents 34 per cent of the total number of rooms in the third cycle.

The Chief Executive of the HKSAR, Mrs Carrie Lam, said that the 14th Five-Year Plan is the blueprint and action agenda for the social and economic development of the country in the next five years. She is delighted that contents relating to Hong Kong can be found in its chapter 61 on maintaining the long-term prosperity and stability of Hong Kong and Macao, and chapter 31 on proactively and progressively taking forward the development of the Guangdong-Hong Kong-Macao Greater Bay Area.

The Government spokesman said that Hong Kong enjoys a high degree of autonomy in handling external affairs under "One Country, Two Systems", and that the HKSAR Government welcomes the support from the 14th Five-Year Plan for Hong Kong to foster co-operation and exchanges with countries and regions around the world and will make the best use of its overseas and Mainland Economic and Trade Offices to explore more opportunities for developing bilateral and multilateral co-operation.
