Currently, except for Hong Kong residents, all travellers arriving Hong Kong by flights from overseas countries/territories will be denied entry. The same restriction also applies to non-Hong Kong residents travelling to Hong Kong from the Mainland of China, Macao and Taiwan who have been to any overseas countries/territories in the past 14 days. These temporary restrictions will remain in force until further notice. In addition, travellers from Canada are required to present test report, in English or Chinese, showing a negative COVID-19 nucleic acid test administered within 72 hours of the scheduled time of departure, before boarding the flight. They are required to present documentary proof in English to show that the laboratory or healthcare institution is recognized/ approved/ ISO15189 accredited. The same requirements apply to a Hong Kong resident who has stayed in Canada during the 21 days before boarding the flight to Hong Kong. Government welcomes IMF's assessment commending Hong Kong's sound macroeconomic and prudential policies and resilience and stability of its financial system

The HKSAR Government welcomes the release of a report on June 9 by the International Monetary Fund (IMF) which reaffirms Hong Kong's position as an international financial centre with a resilient financial system, sound macroeconomic and prudential policies, and robust regulatory and supervisory frameworks.

The IMF's affirmation is carried in the Financial System Stability Assessment (FSSA) Report, published following a comprehensive assessment conducted by the IMF on Hong Kong's financial system under its Financial Sector Assessment Program (FSAP).

The IMF commends in the FSSA Report that Hong Kong's macroeconomic and prudential policies have provided it with important buffers to cope with the current economic slowdown and future shocks. Underpinned by large foreign exchange reserves, Hong Kong's Linked Exchange Rate System has continued to support financial stability. Robust regulatory and supervisory policy frameworks are in place to support the development of the financial sector, and the institutional framework for systemic risk monitoring and oversight is well established. Rigorous stress tests performed by the IMF confirm that Hong Kong's financial system remains resilient in extreme stress scenarios.

The FSSA Report also considers that Hong Kong is well positioned to develop financial technology, leveraging its traditional strengths in financial services. It acknowledges the rapid development of the fintech industry, noting that the authorities play an active role in promoting Hong Kong as a fintech hub in Asia and adopt a proactive approach to promote financial innovation and inclusion. It also notes Hong Kong's solid regime to fight money laundering and terrorist financing.

The FSAP is a comprehensive and in-depth assessment conducted by the IMF. Hong Kong is one of 47 jurisdictions with systemically important financial sectors that have been identified for mandatory review under the FSAP.

# Government tightens boarding requirements for persons arriving from certain overseas places

In view of the persistent unstable epidemic situation in various overseas places, the HKSAR Government announced on June 11 that it will specify Colombia and Korea from Group C specified places to Group B specified places with effect from June 18.

Persons arriving at Hong Kong who have stayed in any Group B specified place(s), including Canada, per the day of boarding for Hong Kong or during the 14 days before that day will have to present at boarding a negative result proof of a nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft, as well as the confirmation of a room reservation in a designated quarantine hotel in Hong Kong. Persons arriving at Hong Kong who have stayed in Group B specified place(s) but are yet to be fully vaccinated with COVID-19 vaccines will be subject to a 21-day compulsory quarantine at designated quarantine hotels, with four tests to be conducted during the period. Those who have been fully vaccinated will be subject to a 14-day compulsory quarantine at designated quarantine hotels, with three tests to be conducted during the period, followed by a seven-day self-monitoring period as well as compulsory testing on the 16th and 19th day of arrival at Hong Kong.

The above directions and specifications took effect till June 23.

A spokesman for the Food and Health Bureau of the HKSAR Government said that a number of local cases with the N501Y mutant strain have been recorded in Hong Kong recently. To guard against a rebound of the epidemic situation, it is not appropriate to relax social distancing measures at the moment.

# HKSARG strongly refutes the remarks contained in latest UK Six-monthly Report on Hong Kong and opposes EU's interference in HK's electoral matters

The HKSAR Government objects to the inaccurate remarks on Hong Kong in the United Kingdom Six-monthly Report on Hong Kong (the Report) released on June 10.

The government spokesman said that the comments in the Report smearing the Law of the People's Republic of China (PRC) on Safeguarding National Security in the HKSAR (Hong Kong National Security Law) could not be further from the truth, and are clearly adopting double standards.

He stressed that the HKSAR is an inalienable part of the PRC, is a local administrative region that enjoys a high degree of autonomy under "one country, two systems" and comes directly under the Central People's Government (CPG). To uphold and implement the principle of "one country, two systems" meets the interests of the Hong Kong people, responds to the needs of maintaining Hong Kong's prosperity and stability and serves the fundamental interests of the nation. The CPG repeatedly urged foreign parties to stop intervening in Hong Kong affairs. Foreign governments should not attempt to interfere in the HKSAR's affairs under international laws and basic principles of non-intervention.

The Central Authorities take the initiative from the national level to improve the electoral system of the HKSAR, aiming to plug the loopholes in and eliminate the deficiencies of the existing electoral system. Through constructing a democratic system that is consistent with the actual situation of Hong Kong, it fully conforms to the constitutional order under the "one country, two systems" principle and manifests Hong Kong characteristics that can thereby put Hong Kong back on track and make rectification.

He emphasised that the HKSAR Government firmly opposes the misleading claims by the EU concerning the improvement to the electoral system as well as their ulterior motives. The improvement to the electoral system of the HKSAR is both timely and necessary. The HKSAR Government is committed to ensuring elections being conducted in a fair, just and open manner.

Since the implementation of the Hong Kong National Security Law, stability has been restored to society and national security has been safeguarded in the HKSAR. The protection of human rights and freedom are all enshrined in the Basic Law.

# Investment Promotion and Protection Agreement between Hong Kong and Mexico to enter into force

The Investment Promotion and Protection Agreement (IPPA) between Hong Kong and Mexico will enter into force on June 16. The IPPA with Mexico will enhance the confidence of investors, expand investment flows between Hong Kong and Mexico, and further strengthen bilateral economic and trade ties.

Under the IPPA with Mexico, the two sides undertake to provide investors of the other side with fair, equitable and non-discriminatory treatment of investments; compensation in the event of expropriation of investments; and the right to free transfers abroad of investments and returns. The IPPA also provides for settlement of investment disputes under internationally accepted rules, including arbitration.

The IPPA with Mexico is the fourth such agreement that the HKSAR Government has signed this term. The other three were signed respectively with the Association of Southeast Asian Nations (ASEAN), Australia and the United Arab Emirates (UAE), all of which have entered into force. Taking into account the IPPA with Mexico, the total number of IPPAs in force between Hong Kong and foreign economies, including Canada, will

#### CE promotes Hong Kong as arts and cultural hub

The Chief Executive of the HKSAR, Mrs Carrie Lam on June 7 met with representatives of Mainland and overseas art galleries via a webinar. She briefed them on Hong Kong's growing competitive edge as an international arts and cultural hub, and that it is the best time for them to expand their presence in the city.

The webinar was organised by Art Basel. Apart from senior executives of Art Basel, the webinar was attended by a dozen of directors and founders of art galleries in major cities around the world, including New York, London, Paris, Rome, Milan, Athens, Tokyo, Seoul, Singapore, Jakarta and Mainland cities.

Mrs Lam said that Hong Kong has all along been an East-meets-West hub for international arts and cultural exchanges. To promote cultural co-operation, Hong Kong has signed memoranda of understanding on cultural co-operation with 20 countries.

Mrs Lam noted that Hong Kong has been investing heavily in upgrading existing cultural hardware and building new facilities. The M+ Museum and the Hong Kong Palace Museum in the West Kowloon Cultural District are expected to be commissioned at the end of this year and in the middle of next year, respectively. The renovated and expanded Hong Kong Museum of Art will be another cultural landmark in the city.

Mr Yau also spoke at another session on how APEC can build momentum towards achieving concrete results at the upcoming 12th Ministerial Conference of the World Trade Organization.

Chaired by the Minister for Trade and Export Growth of New Zealand, Mr Damien O'Connor, the virtual MRT meeting was the first ministerial-level meeting of APEC this year. Participating ministers exchanged views on economic and trade policies to facilitate recovery from COVID-19 and reaffirmed their commitment to the MTS.
