In response to the local government's appeal for concerted efforts to contain the spread of COVID-19, the Hong Kong Economic and Trade Office (Toronto) (HKETO) is closed temporarily. You may reach us via the following channels:

Under the border control measures of the Hong Kong Special Administrative Region (HKSAR) Government introduced on August 9, 2021, overseas places are categorised into high-risk, medium-risk and low-risk groups. Canada is currently in Group B (Medium-risk) group, under which Hong Kong residents and fully vaccinated non-Hong Kong residents are allowed to board flights for Hong Kong.

Travellers from Canada are required to present at boarding (i) a negative result proof of a polymerase chain reaction (PCR)-based nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft; (ii) confirmation in English or Chinese of room reservation in a designated quarantine hotel in Hong Kong; and (iii) a vaccination record if applicable. The same requirements apply to travellers who have stayed in Canada during the 14 days before boarding the flight to Hong Kong. Director of the HKETO, Ms Emily Mo, joined the "Think Asia, think Hong Kong: Team HKCBA Virtual Delegation to Hong Kong Forum 2021" webinar hosted by the Hong Kong-Canada Business Association (HKCBA) and Hong Kong Trade Development Council (HKTDC) on October 21. This webinar aims to share with participants on how participants have benefited from the past Hong Kong Forum, to explore opportunities in Asia and most importantly, and how they can take advantage of the virtual Forum to be held from November 30 to December 1 this year.

In delivering a speech entitled "Hong Kong in the New Normal", Ms Mo shared with participants on the latest global economic development noting that China and Hong Kong had recorded positive GDP growth when the world was hit by COVID-19 last year.

Ms Mo highlighted that the HKSAR Government had published a "Report on Hong Kong's Business Environment" which reviews and sets out Hong Kong's current business environment and advantages and describes the development opportunities available to Hong Kong. Director of the HKETO, Ms Emily Mo, attended the "Canadian Virtual Mission to Asia Summit on Global Health (ASGH)" pre-mission networking meeting jointly organised by

HKETO, HKTDC, Invest Hong Kong (Canada) and the HKCBA on October 27. The first ASGH will be held in Hong Kong on November 24.

In delivering the welcome remarks, Ms Mo shared with participants that Hong Kong has the highest life expectancy in the world, and according to the Economist's research, the city ranked number 1 in returning to life normalcy during the global pandemic in the past summer.

Ms Mo also noted that the HKSAR Government has set up two "InnoHK research clusters" at the Hong Kong Science and Technology Parks. The clusters have focused on the major areas of healthcare technologies, artificial intelligence and robotics technologies. This project has since attracted many top-notch universities, research institutions and partners including the University of Waterloo.

Ms Mo also introduced to the Canadian health sector that a new policy has been launched to cope with the health manpower shortage in Hong Kong. The HKSAR Government has created a new pathway to allow non-locally trained doctors to apply for full registration in Hong Kong after fulfilling a set of criteria.

#### Government adjusts COVID-19 vaccination requirements for inbound travellers

The HKSAR Government announced on October 26 to adjust two COVID-19 vaccination requirements for inbound travellers starting from October 29. The two sets of requirements cover inbound travellers aged 12 to 17 who have received one dose of Comirnaty vaccine, and Hong Kong residents who have received one dose of recognised COVID-19 vaccine but are deemed unfit to receive the second dose because of health reasons.

In addition, the HKSAR Government announced on October 25 and November 1 respectively that it has concluded discussions with the relevant Governments to accept vaccination records issued by Cambodia, Argentina and Armenia as recognised vaccination records for Hong Kong residents who have stayed in Group A specified places for boarding flights for Hong Kong. The vaccines administered for the relevant travellers have to be vaccines listed on the Government's List of COVID-19 Vaccines Recognised for Specified Purposes.

# Government maintains social distancing measures under Prevention and Control of Disease Ordinance

The HKSAR Government gazetted the extension of existing social distancing measures till November 10. The government spokesman noted that under the proactive "zero case" prevention and control strategy, the HKSAR Government has been implementing extremely stringent border control measures which enabled the city's daily activities and socio-economic activities to largely resume with relatively relaxed social distancing measures, while maintaining a stable epidemic situation for a long period of time.

In addition, the Government also announced on October 26 that the criteria for releasing confirmed COVID-19 patients from isolation would be updated, and the discharge criteria for confirmed patients would be tightened. The relevant arrangements came into effect from October 27.

A Government spokesman said that as patients who have recovered from infection recently may still carry the virus, the latest arrangement would further reduce the risk of such patients bringing the virus into the community to a minimum.

#### Hong Kong Economic and Trade Office in Dubai commences operation

The Hong Kong Economic and Trade Office in Dubai (Dubai ETO) commenced operation on October 28. It is the HKSAR Government's first ETO in the Middle East region and its opening will strengthen Hong Kong's economic and trade relations with trading partners in the region, in particular the six member states of the Cooperation Council for the Arab States of the Gulf (GCC).

The occasion was marked by an opening ceremony held at the Dubai ETO. Addressing the opening ceremony of the Dubai ETO by way of a video message, the Chief Executive of the HKSAR, Mrs Carrie Lam, said the establishment of the Dubai ETO underscored the importance Hong Kong attaches to the partnership with the United Arab Emirates (UAE) and the five other member states of the GCC.

Ms Lam noted that the new office would assist businesses and investors throughout the region to take advantage of Hong Kong's singular opportunities, including those brought about by the Guangdong-Hong Kong-Macao Greater Bay Area and the National 14th Five-Year Plan, which back Hong Kong's rise as a global innovation and technology hub and support the enhancing of the city's long-standing strengths in financial services, trade and transport, together with its international development in such areas as culture, legal and dispute-resolution services and intellectual property trading.

The geographical coverage of the Dubai ETO includes the six member states of the GCC, namely Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the UAE.

#### FS attends APEC Finance Ministers' Meeting 2021

The Financial Secretary of the HKSAR, Mr Paul Chan, on October 22 attended the virtual Asia-Pacific Economic Cooperation (APEC) Finance Ministers' Meeting (FMM) 2021.

Mr Chan addressed the meeting on the HKSAR government's fiscal strategies for addressing the COVID-19 pandemic, and the opportunities and challenges presented by the pandemic for the global economy. Sharing the experience of Hong Kong with meeting participants, Mr Chan underlined the importance of timely expansionary fiscal policy, coupled with effective anti-epidemic measures.

Mr Chan also remarked that Hong Kong strived to achieve carbon neutrality by 2050 through increasing investment in green projects. The city will issue green bonds totalling around US\$23 billion to support the implementation of green projects in the coming five years.

The FMM 2021 was hosted by New Zealand and chaired by the Deputy Prime Minister and Minister of Finance of New Zealand, Mr Grant Robertson. Participating ministers exchanged views on the use of fiscal policy and budget management to address ongoing challenges arising from the pandemic for a sustainable and inclusive recovery.

The meeting also concluded with the issuance of an FMM Statement, in which finance ministers reaffirmed their commitment to adopt fiscal and budget policy to tackle long-standing challenges, encourage digital transformation, and continue co-ordinated

multilateral co-operation in supporting strong, sustainable, balanced and inclusive recovery.
