In response to the local government's appeal for concerted efforts to contain the spread of COVID-19, the Hong Kong Economic and Trade Office (Toronto) (HKETO) is closed temporarily. You may reach us via the following channels:

Under the border control measures of the Hong Kong Special Administrative Region (HKSAR) Government introduced on August 9, 2021, overseas places are categorised into high-risk, medium-risk and low-risk groups. With effect from 2 December, 2021 Canada will be specified as Group A (High-risk) group, under which non-Hong Kong residents who have stayed in Canada during the 21 days before boarding the flight to Hong Kong are not allowed to enter Hong Kong.

For Hong Kong residents, they can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. They have to undergo compulsory quarantine in a designated quarantine hotel (DQH) for 21 days upon arrival at Hong Kong, with six tests to be conducted during quarantine, followed by compulsory testing in a Community Testing Centre on the 26th day of arrival at Hong Kong. Travellers from Canada are required to present at boarding (i) a negative result proof of a polymerase chain reaction (PCR)-based nucleic acid test for COVID-19 conducted within 72 hours before the scheduled time of departure of the aircraft; (ii) confirmation in English or Chinese of room reservation in a designated quarantine hotel in Hong Kong; and (iii) a recognised vaccination record. HKSAR Government tightens boarding and quarantine requirements for places including Canada with Omicron cases

The HKSAR Government announced on November 29 and November 30 that in view of the latest global developments of the COVID-19 pandemic situation, the Government will specify Australia, Austria, Belgium, **Canada**, the Czech Republic, Denmark, Germany, Israel and Italy as Group A specified places from 0.00am on December 2, and Japan, Portugal and Sweden from 0.00am on December 3 to tighten the boarding and quarantine requirements for relevant inbound travellers. Non-Hong Kong residents who have stayed there within 21 days are not allowed to enter Hong Kong. Hong Kong residents can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. They have to undergo compulsory quarantine in a DQH for 21 days upon return to Hong Kong, with six tests to be conducted during quarantine, followed by compulsory testing in a community testing centre on the 26th day of arrival at Hong Kong.

Additionally, the Government announced earlier that, to maintain our vigilance, inbound travellers from Angola, Botswana, Eswatini, Ethiopia, Lesotho, Malawi, Mozambique, Namibia, Nigeria, South Africa, Zambia and Zimbabwe, which had been specified as Group A specified places, are subject to more stringent quarantine and testing



requirements (i.e. Group A places with enhanced surveillance). Hong Kong residents arriving from these Group A places with enhanced surveillance are required to undergo compulsory quarantine at the Penny's Bay Quarantine Centre for the first seven days, and would then be transferred by designated transport to finish the remaining 14 days of compulsory quarantine at the DQH which they have reserved before coming to Hong Kong.

In the meantime, to further prevent the transmission of COVID-19, the HKSAR Government issued on November 24 directions under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F) to stipulate that a person under compulsory quarantine at a DQH and his or her accompanying carer must not wear a mask with any exhalation valve or vent as these masks cannot effectively filter droplets in exhaled air. The risk posed to surrounding people will be increased if the wearer is infected with novel coronavirus or other respiratory viruses.

Government maintains most social distancing measures under Prevention and Control of Disease Ordinance

The HKSAR Government gazetted the extension of most existing social distancing measures till December 8. A spokesman for the Food and Health Bureau of the HKSAR Government said on November 23 that amid the severe pandemic situation across the world, the Government strives to maintain the anti-epidemic strategy of guarding against the importation of cases and the resurgence of domestic infections with the target of zero infection to protect public health and foster favourable conditions for resuming cross-boundary travel with the Mainland China and cross-border travel in future. To this end, the city needs to maintain most of the social distancing measures currently in place.

Also, the Government announced on November 18 that members of the public who have received two doses of the Sinovac vaccine with the second dose received six months ago, irrespective of whether they belong to the certain groups, can make reservations for and receive a third dose of a COVID-19 vaccine starting from November 23.

In addition, the Secretary for Food and Health of the HKSAR (SFH) has also approved extending the age eligibility of the CoronaVac vaccine to cover those aged three to 17. Also, having regard to the recommendations made by the Scientific Committee on Vaccine Preventable Diseases and the Scientific Committee on Emerging and Zoonotic Diseases under the Centre for Health Protection of the Department of Health together with the Chief Executive's expert advisory panel, the SFH agreed that adolescents aged 12 to 17 will be accorded priority to receive the CoronaVac vaccine, with a view to extending to children of a younger age group at a later stage.

Hong Kong FinTech Week 2021 celebrates global hub's scale-up opportunities

Hong Kong FinTech Week (HKFW) 2021 ended on November 5, closing a global conference exploring an array of business opportunities for the fintech industry in Hong Kong and across the Guangdong-Hong Kong-Macao Greater Bay Area.

The five-day event championed "Scaling FinTech Future Together" attracted over 20 000 attendees. The conference was host to over 300 renowned speakers from around the world, more than 400 exhibitors, and 39 international delegations and representatives. Twenty-seven satellite events and thousands of business meetings were arranged through the event and via the online platforms. This was the first HKFW in a hybrid format, drawing more than four million online views and providing a seamless experience to worldwide audiences from 87 economies to learn more about the city's fast-growing fintech ecosystem.

The Financial Secretary of the HKSAR, Mr Paul Chan, said that despite COVID-19 and numerous other challenges, Hong Kong remains a prime international financial centre. The National 14th Five-Year Plan supports Hong Kong's continuing efforts to reinforce the city's status as a global financial centre and offerings, and backs the development of Hong Kong as an international innovation and technology hub. Thanks to the "one country,



two systems" institutional strength, Hong Kong remains the destination of choice for fintech companies looking to operate or expand, locally, regionally and globally.

SCED: Hong Kong business environment remains favourable and vibrant

The Secretary for Commerce and Economic Development of the HKSAR, Mr Edward Yau, assured participants of a webinar on November 19 that the business environment of Hong Kong remains favourable and vibrant, saying that with the implementation of the National Security Law and improvements to the electoral system, Hong Kong is back on the right track of "one country, two systems", with developments characterised by safety, security and stability.

Speaking at a webinar of the 2021 World Alliance Forum, Mr Yau illustrated Hong Kong's recent achievements, including being ranked the world's sixth largest merchandise trading economy in terms of total merchandise trade value last year; being ranked the third largest recipient of foreign direct investment in 2020 by the United Nations Conference on Trade and Development report; and first in Asia and second worldwide in the World Digital Competitiveness Ranking 2021.

In addition, total merchandise trade value has also hit a record high in the first nine months of this year. IPO funds raised in Hong Kong increased by more than 50 per cent compared to the previous 12 months. The number of business operations in Hong Kong with parent companies outside Hong Kong, and the number of start-ups in Hong Kong this year also reached record highs.

Mr Yau updated participants on Hong Kong's vibrant innovation and technology ecosystem. He added that Hong Kong is now already the largest biotech fundraising hub in Asia, second only to the Nasdaq in the world.

AALCO Annual Session held in HKSAR for first time

The 59th Annual Session of the Asian-African Legal Consultative Organization (AALCO) was successfully launched on November 29. It is the first time for the HKSAR to hold an AALCO Annual Session. The three-day event is conducted in a hybrid format, bringing high-ranking diplomats and legal experts representing the member states as well as



observer delegations representing governments and international organisations from across the globe together to discuss important international law topics.

At the inaugural session, Premier Li Keqiang delivered a statement online. He pointed out that as an important outcome of the Bandung Conference, the AALCO is the only platform covering both Asia and Africa for co-operation on international law. The Premier has made five proposals:

- (1) to uphold sovereign equality and jointly practice multilateralism
- (2) to strengthen connectivity and jointly advance opening-up for mutual benefit
- (3) to build a strong line of defence against the coronavirus and jointly strengthen global health governance
- (4) to accelerate a green transition and jointly promote sustainable development
- (5) to uphold fairness and justice, and jointly strengthen international rule of law

The Premier also announced at the event that China, together with AALCO, will set up a regional arbitration centre in the HKSAR to provide more accessible and efficient dispute settlement services to Asian and African countries.

In addressing the inaugural session via video message, the Chief Executive of the HKSAR, Mrs Carrie Lam, said that China's persistence in building a "community with shared future for mankind" is highly congruent with the values advocated by AALCO and United Nations 2030 Agenda for Sustainable Development. China has taken a proactive role in integrating the implementation of sustainable development goals with its own national development strategy, promoting rule of law infrastructure across the globe and sustainable development through collaboration of countries.

The AALCO, as the only inter-governmental legal consultative organisation in the Asian and African region, currently has 47 member states comprising almost all the major states from Asia and Africa.

Cash Payout Scheme registration to close on December 31

A government spokesman said on November 25 that the Cash Payout Scheme announced in the 2020-21 Budget has been operating smoothly since registration commenced on June 21, 2020. As at November 23 this year, the Scheme had disbursed HK\$10,000 each to more than 6.5 million eligible registrants.

Registration for the Scheme will end on December 31 this year. Persons who meet the eligibility criteria but have not yet registered should submit registrations electronically or by paper form on or before the registration deadline to receive HK\$10,000.
