In response to the local government's appeal for concerted efforts to contain the spread of COVID-19, the Hong Kong Economic and Trade Office (Toronto) (HKETO) is closed temporarily. You may reach us via the following channels:

Under the border control measures of the Hong Kong Special Administrative Region (HKSAR) Government introduced on August 9, 2021, overseas places are categorised into high-risk, medium-risk and low-risk groups. With effect from 2 December, 2021 Canada will be specified as Group A (High-risk) group, under which non-Hong Kong residents who have stayed in Canada during the 21 days before boarding the flight to Hong Kong are not allowed to enter Hong Kong.

In view of the rapidly worsening global epidemic situation due to the Omicron variant, a series of measures have been implemented, including the following:

- 1) shortening the lead time for specimen collection for pre-departure nucleic acid tests for persons boarding for flights to Hong Kong from 72 hours to 48 hours with effective from December 24; and
- 2) requiring persons arriving at Hong Kong from Group A places with enhanced surveillance to undergo compulsory quarantine at a quarantine centre for the first four days of arrival at Hong Kong with effect from December 21. They have to undergo daily testing in the first seven days of arrival at Hong Kong, and to undergo testing on alternate days thereafter.

For Hong Kong residents, they can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. Please refer to the following press release for details:

Travellers from Canada are required to present at boarding (i) a negative result proof of a polymerase chain reaction (PCR)-based nucleic acid test for COVID-19 conducted within 48 hours before the scheduled time of departure of the aircraft; (ii) confirmation in

Government implements place-specific flight suspension mechanism and tightens boarding and quarantine requirements for places in response to Omicron variant

The HKSAR Government announced on January 5 that in view of the rapidly worsening global pandemic situation due to the Omicron variant, and with reference to inbound passenger traffic and the number of imported cases, it will, from January 8 to January 21, implement the place-specific flight suspension mechanism for Australia, Canada, France, India, Pakistan, the Philippines, the United Kingdom and the United States of America. All passenger flights from these eight places will be prohibited from landing in Hong Kong, and at the same time, persons who have stayed in these places for more than two hours will be restricted from boarding passenger flights for Hong Kong, so as to stop persons from the relevant places from travelling to Hong Kong via transit.

Meanwhile, Hongkong Post announced on December 31 that, owing to the substantial reduction in flight frequencies or even cancellation of flights by airlines for certain destinations, all airmail services (including Speedpost) to Australia, Canada, Mexico and the United States will be suspended from January 1 until further notice. Hongkong Post will continue working closely with air freight contractors for resumption of the impacted services as soon as possible.

On the other hand, the HKSAR Government announced over the last two weeks that in view of the latest global developments of the COVID-19 pandemic situation, the countries below have been specified as Group A specified places and the boarding and quarantine requirements for relevant inbound travellers will be tightened:

Belarus, Curação and Vietnam from January 2 Libya from January 3

Barbados, Bosnia and Herzegovina, Guinea, St Kitts and Nevis, St Vincent and the Grenadines, and Uruguay from January 4

Bulgaria from January 6
Martinique from January 7
Cape Verde, Niger and South Sudan from January 8
Grenada, Mauritania and Mayotte from January 9
Iraq from January 10
Antigua and Barbuda, Bolivia, Cote d'Ivoire, Gabon, Gambia, Laos and Mongolia from January 11
Solomon Islands from January 12
Uzbekistan from January 13

Non-Hong Kong residents who have stayed in the above countries within 21 days will not be allowed to enter Hong Kong. Hong Kong residents can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. They will have to undergo compulsory quarantine in a designated quarantine hotel for 21 days upon returning to Hong Kong, with six tests to be conducted during quarantine, followed by compulsory testing in a community testing centre on the 26th day of arrival in Hong Kong.

A total of 44 hotels will provide about 12 500 rooms in the new cycle, which runs from March 1 to July 31, 2022. The Government may adjust the number of rooms available in this cycle as and where necessary.

#### Government tightens social distancing measures in view of latest epidemic situation

In view of the development of COVID-19 epidemic situation in Hong Kong, the HKSAR Government announces on January 5 that it would tighten social distancing measures with effect from January 7 to January 20.

A Government spokesman said that the virus had spread into the local community due to several imported cases concerning exempted air crew members, and silent transmission chains may have already existed in the community. The HKSAR Government must adopt stringent measures with a view to containing the epidemic as early as possible. The Government will tighten social distancing measures to the most stringent level as seen during the third and fourth waves of the epidemic, with a view to reducing public traffic, social functions and crowd gatherings to the greatest extent.

# Hong Kong residents born in 1983, 1984, 1987 or 1988 should apply for new smart identity cards between January 19 and April 2

The Immigration Department of the HKSAR Government announced on January 5 that Hong Kong residents born in 1983, 1984, 1987 or 1988 and holding the old form of smart identity card should bring along their identity cards and apply for new smart identity cards in person at a Smart Identity Card Replacement Centre from January 19 to April 2.

The Territory-wide Identity Card Replacement Exercise covers all Hong Kong residents, who should apply for new smart identity cards in person at the SIDCCs during specified periods, whether they are permanent residents or non-permanent residents who are permitted to take up employment, make investment, reside or study in Hong Kong.
