In response to the local government's appeal for concerted efforts to contain the spread of COVID-19, the Hong Kong Economic and Trade Office (Toronto) (HKETO) is closed temporarily. You may reach us via the following channels:

Under the border control measures of the Hong Kong Special Administrative Region (HKSAR) Government introduced on August 9, 2021, overseas places are categorised into high-risk, medium-risk and low-risk groups. With effect from 2 December, 2021 Canada will be specified as Group A (High-risk) group, under which non-Hong Kong residents who have stayed in Canada during the 21 days before boarding the flight to Hong Kong are not allowed to enter Hong Kong.

In view of the rapidly worsening global epidemic situation due to the Omicron variant, a series of measures have been implemented, including the following:

- 1) shortening the lead time for specimen collection for pre-departure nucleic acid tests for persons boarding for flights to Hong Kong from 72 hours to 48 hours with effective from December 24; and
- 2) requiring persons arriving at Hong Kong from Group A places with enhanced surveillance to undergo compulsory quarantine at a quarantine centre for the first four days of arrival at Hong Kong with effect from December 21. They have to undergo daily testing in the first seven days of arrival at Hong Kong, and to undergo testing on alternate days thereafter.

For Hong Kong residents, they can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. Please refer to the following press release for details:

HKETO Director updates Hong Kong's latest business developments

Director of the HKETO, Ms Emily Mo, on January 18 joined the "Hong Kong Deep Dive: Quantifying the Economic Impact of China and Hong Kong in Canada" webinar to update the Canadian business community on Hong Kong's latest business developments.

The webinar, organised by the Canada China Business Council (CCBC) and HKCBA, released the "Hong Kong-Canada Economic Ties" report on a CCBC-commissioned research by the China Institute at the University of Alberta. It provides a fact-based overview of Canada-Hong Kong trade, investment, and people-to-people bi-lateral relations, and serves as a useful reference for various sectors to understand how the relations may further deepen in future.

The report points out that Canada's relationship with Hong Kong is distinct, and the economic and business opportunities between the two places remain abundant and profitable. It concludes that Hong Kong is an important nexus of international trade due to its free port status and its special relationship with mainland China and access to Asia. Hong Kong has remained one of Canada's top ten trading markets.

Government extends place-specific flight suspension mechanism and tightens boarding and quarantine requirements for places with Omicron cases detected

The HKSAR Government announced on January 14 that in view of the continuously worsening global epidemic situation due to the Omicron variant, the place-specific flight suspension mechanism for Australia, **Canada**, France, India, Pakistan, the Philippines, the United Kingdom and the United States of America will be extended to February 4. All passenger flights from these eight places will be prohibited from landing in Hong Kong, and at the same time, persons who have stayed in these places for more than two hours within 21 days will be restricted from boarding passenger flights for Hong Kong, so as to stop persons from the relevant places from travelling to Hong Kong via transit.

Meanwhile, the HKSAR Government announced over the last two weeks that in view of the latest global developments of the COVID-19 pandemic situation, the countries below have been specified as Group A specified places and the boarding and quarantine requirements for relevant inbound travellers will be tightened:

Kyrgyzstan from January 16
Armenia, Bonaire, Guatemala and New Caledonia from January 17
Bhutan from January 19
Honduras from January 21
Papua New Guinea and Suriname from January 22
Turks and Caicos Islands from January 25

Non-Hong Kong residents who have stayed there within 21 days will not be allowed to enter Hong Kong. Hong Kong residents can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. They will have to undergo compulsory quarantine in a designated quarantine hotel for 21 days upon returning to Hong Kong, with six tests to be conducted during quarantine, followed by compulsory testing in a community testing centre on the 26th day of arrival in Hong Kong.

IMF commends Hong Kong's robust institutional frameworks and effective policy responses for boosting economic growth and safeguarding financial stability

Following the completion of the 2022 Article IV Consultation with the HKSAR, the International Monetary Fund Staff Mission (Mission) published on January 20 its assessment in the Concluding Statement. The Mission commends Hong Kong's strong economic recovery and the Government's efforts to safeguard financial stability.

The Mission reaffirms Hong Kong's position as a major international financial centre and recognises that Hong Kong's financial sector, underpinned by robust regulatory and supervisory frameworks, has continued to expand robustly, even during the pandemic. The well-functioning Linked Exchange Rate System remains key to safeguarding economic and financial stability.

The Financial Secretary of the HKSAR, Mr Paul Chan, welcomed the Mission's recognition of Hong Kong's strong economic recovery supported by the city's swift and bold policy responses, including the electronic consumption voucher scheme and various anti-epidemic support measures. Mr Chan reassured that the government would continue to stay highly vigilant and monitor the economic situation closely, with a view to maintaining financial stability and fostering balanced, inclusive and sustainable growth.

The Mission adds that the development of the Guangdong-Hong Kong-Macao Greater Bay Area would generate huge business opportunities and provide the best entry point for Hong Kong to integrate into the national development, thereby benefitting Hong Kong's medium- and long-term growth prospects.

The Mission also commends the large fiscal stimulus that has helped mitigate the impact of economic shocks on Hong Kong. It also recognises the HKSAR Government's ongoing efforts to enhance the green and sustainable finance ecosystem.

The Mission held virtual discussions with government officials, regulators and private sector representatives in Hong Kong from December 1 to 15, 2021, for the 2022 Article IV Consultation with the HKSAR. Hong Kong and Chile update commitments on trade in services under Free Trade Agreement

Hong Kong and Chile signed an exchange of notes on January 18 to confirm the updated commitments of both sides on trade in services under the Free Trade Agreement (FTA) between Hong Kong and Chile, marking a new milestone in trade and investment cooperation between the two economies.

The Secretary for Commerce and Economic Development of the HKSAR, Mr Edward Yau, and the Vice Minister of Trade of Chile, Mr Rodrigo Yáñez, signed the exchange of notes at a virtual signing ceremony.

Mr Yau noted that Chile is the first FTA partner of Hong Kong in Latin America. Since the FTA has entered into force in 2014, bilateral merchandise trade has been growing steadily.

In addition to improving its existing commitments in a wide variety of service sectors, Chile has made commitments in over 50 new service sectors. For these sectors, Hong Kong's service providers would be able to enjoy access to the Chilean market and treatment no less favourable than that for Chile's local service providers.

Hong Kong has signed eight FTAs with 20 economies worldwide, all of which have entered into force.

HKSAR Government strongly opposes resolutions of European Parliament

The HKSAR Government on January 21 deplored the so-called resolutions adopted by the European Parliament against Hong Kong, and strongly opposed the Parliament for making baseless allegations and smearing the rule of law, freedom and democratic development in Hong Kong.

A HKSAR Government spokesman said that regarding the suggestions by foreign politicians on the so-called "sanctions" on HKSAR Government officials, the HKSAR Government despises the suggestions and will continue to strive to safeguard national security.

The spokesman stressed that the improvement to the electoral system fully implements the principle of "patriots administering Hong Kong", ensuring that members of the Legislative Council love the country and Hong Kong, and act in the interests of the country's development and the long-term prosperity and stability of Hong Kong.

The spokesman also noted that the democratic framework implemented by Hong Kong since its return to the Motherland stems from the country's Constitution and the Basic Law. Freedom of speech and freedom of the press are protected under the Basic Law and the Hong Kong Bill of Rights. Article 4 of the Hong Kong National Security Law also stipulates that such rights and freedoms shall be protected in accordance with the law in safeguarding national security in the HKSAR.

The spokesman remarked that the policy of "one country, two systems" ensures Hong Kong's long-term prosperity and stability and is fully implemented in Hong Kong without being bent or distorted.
