Under the border control measures of the Hong Kong Special Administrative Region (HKSAR) Government, overseas places are categorised into high-risk, medium-risk and low-risk groups. Canada is currently specified as Group A (High-risk) group and also on the "List of Specified Places with Flight Suspension". Travellers who have stayed in Canada during the 14 days before boarding the flight to Hong Kong are not allowed to enter Hong Kong.

In view of the rapidly worsening global epidemic situation due to the Omicron variant, a series of measures have been implemented, including the following:

- 1. the place-specific flight suspension mechanism for Canada has been extended to February 18:
- 2. from February 5, the compulsory quarantine period for inbound travellers from overseas places has been adjusted to 14 days in designated quarantine hotels (DQH), to be followed by a seven-day self-monitoring period;
- 3. shortening the lead time for specimen collection for pre-departure nucleic acid tests for persons boarding for flights to Hong Kong to 48 hours; and
- 4. requiring persons arriving at Hong Kong to undergo six tests during guarantine at DQH and compulsory testing on the 16th and 19th days.

## Government tightens social distancing measures in view of changes in epidemic situation

The HKSAR Government announced on February 8 the gazettal of legislative amendments under the Prevention and Control of Disease Ordinance (Cap. 599), and the tightening of social distancing measures to take effect from February 10 till February 23.

Given the drastic deterioration of the epidemic situation in Hong Kong, the Chief Executive in Council approved four legislative proposals on February 8 with a view to further strengthening epidemic containment measures in light of the currently severe epidemic situation.

The approved proposals involve:

- the amendments to the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation to add six more scheduled premises including religious premises, shopping malls, department stores, supermarkets, markets and barber shops or hair salons;
- the amendments to the Prevention and Control of Disease (Prohibition on Group Gathering) Regulation (Cap. 599G) to restrict the number of persons allowed per group gathering in a public place from four to two. Provisions prohibiting multihousehold gatherings at private premises involving more than two households will also be introduced:
- the enactment of a new Prevention and Control of Disease (Vaccine Pass) Regulation (Cap. 599L) to enable the application of "vaccine pass" in relation to any category of premises; and
- the amendments to the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J), which will raise the fixed penalty for non-compliance with compulsory testing notices.

In addition, in view of the serious epidemic situation, in order to curb the spread of COVID-19, safeguard people's health and protect the healthcare system from collapse, the HKSAR Government launched the "StayHomeSafe" Scheme on February 8. The Centre

for Health Protection of the Department of Health (DH) has started to arrange close contacts and household contacts of close contacts who are deemed appropriate after assessment to undergo home quarantine for 14 days and four days respectively.

Persons undergoing "StayHomeSafe" must stay in their dwelling place and wear an electronic wristband throughout the quarantine period and follow other home quarantine guidelines issued by the DH. The Government has launched a dedicated website for the "StayHomeSafe" Scheme <a href="www.coronavirus.gov.hk/eng/home-quarantine.html">www.coronavirus.gov.hk/eng/home-quarantine.html</a> to provide assistance to persons undergoing "StayHomeSafe".

Government adjusts boarding, quarantine and testing arrangements for inbound travellers and extends arrangement of place-specific flight suspension mechanism

The HKSAR Government announces on January 27 that from February 5, the compulsory quarantine period for inbound travellers from overseas places will be adjusted to 14 days in designated quarantine hotels (DQHs), to be followed by a seven-day self-monitoring period. Meanwhile, the place-specific flight suspension mechanism for Australia, **Canada**, France, India, Pakistan, the Philippines, the United Kingdom and the United States of America (Eight Places) will be extended to February 18.

The Government spokesman said that as transmission of the Omicron variant is already very prevalent in overseas places, all overseas places will be specified as Group A specified places. The quarantine arrangements for all Group A specified places will be aligned. Hong Kong residents who have stayed in a Group A specified place in the previous 14 days can only board a flight for Hong Kong if they have been fully vaccinated and hold a recognised vaccination record. They will have to undergo compulsory quarantine in a DQH for 14 days upon returning to Hong Kong, with six tests to be conducted during quarantine, to be followed by self-monitoring for seven days, and compulsory testing on the 16th and 19th days of arrival at Hong Kong, where the test to be taken on the 19th day must be conducted in a community testing centre. Non-Hong Kong residents who have stayed in Group A specified places will not be allowed to enter Hong Kong.

Meanwhile, noting that the local epidemic situation has been severe, and there has all along been many Hong Kong residents returning from the Eight Places, in order to prevent imported cases from posing additional pressure on the medical system at this crucial juncture of curbing the local epidemic situation, the HKSAR Government extended the place-specific flight suspension mechanism for two weeks. 18, all passenger flights from the Eight Places will be prohibited from landing in Hong Kong, and at the same time, persons who have stayed in these places for more than two hours within 14 days will be restricted from boarding passenger flights for Hong Kong, so as to stop persons from the relevant places from travelling to Hong Kong via transit.

In addition, the HKSAR Government announced on January 31 that three hotels including Dorsett Mongkok, Dorsett Tsuen Wan and Grand City Hotel will be added as quarantine hotels for close contacts of cases tested positive for SARS-CoV-2 virus during the period from February 1 to April 30. With immediate effect, these three hotels temporarily cease operating as DQHs and taking reservations for inbound travellers during the aforementioned period. Persons currently under quarantine at these three hotels will be arranged in phases to transfer to other DQHs to continue their quarantine in accordance with infection control guidelines.

# Import of poultry meat and products from areas in Germany, Spain and Canada suspended

The Food and Environmental Hygiene Department of the HKSAR Government announced on February 7 that in view of notifications from the World Organisation for Animal Health about outbreaks of highly pathogenic H5N1 avian influenza in Oberbergischer Kreis District in the State of Nordrhein-Westfalen in Germany, Huelva Province of Andalucía in Spain and Kings County of Nova Scotia Province in Canada, the trade was instructed to suspend the import of poultry meat and products (including poultry eggs) from the above-mentioned areas with immediate effect to protect public health in Hong Kong.

A spokesman said that according to the Census and Statistics Department, Hong Kong imported about 1 020 tonnes of chilled and frozen poultry meat from Canada last year.
