Under the border control measures of the Hong Kong Special Administrative Region (HKSAR) Government, overseas places are categorised into high-risk, medium-risk and low-risk groups. **Canada** is currently specified as Group A (High-risk) group and also on the "List of Specified Places with Flight Suspension". Travellers who have stayed in Canada during the 14 days before boarding the flight to Hong Kong are not allowed to enter Hong Kong.

In view of the rapidly worsening global epidemic situation due to the Omicron variant, a series of measures have been implemented, including the following:

- 1. the place-specific flight suspension mechanism for Canada has been extended to April 20;
- 2. the compulsory quarantine period for inbound travellers from overseas places has been adjusted to 14 days in designated quarantine hotels (DQH), to be followed by a seven-day self-monitoring period;
- 3. shortening the lead time for specimen collection for pre-departure nucleic acid tests for persons boarding for flights to Hong Kong to 48 hours; and
- 4. requiring persons arriving at Hong Kong to undergo six tests during quarantine at DQH and compulsory testing on the 16th and 19th days.

#### Government extends most social distancing measures

In view of the very dire epidemic situation in Hong Kong, the Government announced on February 22 the tightening of social distancing measures which would be maintained till April 20. The Government further announced on March 8 the gazettal of the social distancing measures to extend most of them in accordance with the public health emergency regulations under the Prevention and Control of Disease Ordinance, with the next 14-day cycle taking effect from March 10 to March 23.

For catering premises and scheduled premises regulated under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F), the existing social distancing measures will be extended for two weeks. In view of citizens' actual demand for relevant services and the smooth implementation of the Vaccine Pass arrangement, barber shops or hair salons will be allowed to reopen with the full implementation of Vaccine Pass requirements.

Other existing measures, such as allowing no more than two persons per group gathering in a public place, prohibition of multi-household gatherings at private premises involving more than two households, mask-wearing requirement and cessation of mass events to avoid group gatherings, will continue to be implemented.

In addition, the Chief Executive of the HKSAR, Mrs Carrie Lam, on March 4 met with the Head of the National Health Commission's COVID-19 leading task force, Professor Liang Wannian, and his expert delegation. Mrs Lam expressed her sincere gratitude to Professor Liang and the experts for their meetings one after another with the relevant officials of the HKSAR Government, representatives of the Hospital Authority, the Government's anti-epidemic expert advisory group and the Advisory Panel on COVID-19 Vaccines, and the faculty of medicine under a local university. Mrs Lam concurred with the experts that the current priority for the HKSAR Government was to focus resources on the patients most in need, prevent mild cases from turning severe, and reduce the number of severe cases and deaths.

# Government explains latest criteria for early discharge from isolation and home quarantine

The HKSAR Government reiterated on March 6 that the latest criteria for early discharge from isolation for persons infected with COVID-19 and discharge from community isolation facilities (CIFs) or home quarantine for close contacts announced earlier is not applicable to those who have not been vaccinated or have only received one dose of COVID-19 vaccine.

For people who have not been vaccinated or have only received one dose of COVID-19 vaccine, no matter whether they are infected persons staying in CIFs, pending admission to hospitals or isolation facilities or close contacts under home quarantine, are required to undergo 14-day medical surveillance at CIF or home. They must also fulfil relevant testing requirements before being considered for completion of isolation or home quarantine.

In addition, the Vaccine Pass arrangement in Hong Kong has been fully implemented from February 24. In view of the updated COVID-19 vaccination arrangements for students and elderly persons, the Government adjusted the vaccination requirements for the Vaccine Pass correspondingly on March 4.

Under the latest vaccination arrangements made in accordance with the recommendation by experts, the time interval between the first dose and the second dose of Comirnaty vaccine for children and adolescents aged five to 17 will be shortened from 12 weeks to eight weeks.

The relevant COVID-19 vaccination requirements for other age groups or applicable persons as well as the specified premises covered by the Vaccine Pass will remain unchanged.
