They must hold a negative result of a polymerase chain reaction (PCR)-based nucleic acid test taken within 48 hours before boarding as well as a confirmation of a room reservation at a designated quarantine hotel for at least seven nights. Pre-departure PCR-based nucleic acid tests are not required for travellers transferring or transiting in Hong Kong or inbound children aged below three.

Government extends existing social distancing measures

The HKSAR Government announced on July 12 the gazettal of the extension of existing social distancing measures in accordance with the public health emergency regulations under the Prevention and Control of Disease Ordinance, which will be effective from July 14 to 27.

In view of the latest epidemic development and to balance the need for social and economic activities, the Government decided to extend the existing social distancing measures for the next 14-day cycle without any relaxation at this juncture. This includes allowing all catering premises and scheduled premises to continue to operate subject to strict compliance with the requirements including use of the Vaccine Pass and "LeaveHomeSafe". Other requirements, such as mask-wearing for citizens in transport carriers and specified public places, as well as prohibition of group gatherings in public places, also remain in force.

The Government also announced on July 12 the addition of two more hotels under the eighth cycle of the Designated Quarantine Hotel (DQH) Scheme. Coupled with these two hotels, there will be altogether 67 DQHs providing around 25 500 rooms.

HKSAR Government welcomes establishment of Swap Connect

The People's Bank of China, the Securities and Futures Commission and the Hong Kong Monetary Authority issued a joint announcement on July 4 on their approval for the specified Mainland and Hong Kong financial institutions to collaborate in establishing mutual access arrangements between the interest rate swap markets of the two places (Swap Connect). The HKSAR Government welcomes the decision.

The Chief Executive, Mr John Lee, said that Swap Connect marks another milestone in the integration of the Mainland and Hong Kong financial markets. It will, for the first time, introduce mutual access in the realm of financial derivatives products, enhancing the comprehensiveness of the product suit trading under the mutual market access schemes.

The Financial Secretary, Mr Paul Chan, said that Swap Connect will help drive forward the development of derivatives markets in the Mainland and Hong Kong, offering more diverse risk management tool options to investors and enhancing the ecosystem for derivatives products of the two places. It will also be conducive to the development of Hong Kong's offshore RMB market, thereby further consolidating Hong Kong's status as an international financial centre and a global offshore RMB business hub.

Northbound trading will be launched first in the initial phase of Swap Connect, allowing Hong Kong and other overseas investors to participate in the Mainland's interbank derivatives market through arrangements in trading, clearing, settlement, etc. between the specified institutions in Hong Kong and the Mainland. Swap Connect will be formally launched after the completion of the necessary preparatory work.

HKSAR Government committed to protecting human rights

The HKSAR Government emphasised its full commitment to the protection of human rights to the United Nations Human Rights Committee (the Committee) at the meeting of HKSAR's fourth report in the light of the International Covenant on Civil and Political Rights (ICCPR) on July 12.

The delegation led by the Secretary for Constitutional and Mainland Affairs, Mr Erick Tsang Kwok-wai, attended the meetings of the Committee by videoconferencing on July 7, 8 and 12 and introduced the implementation of the ICCPR in the HKSAR.

Mr Tsang stated that human rights are guaranteed constitutionally by both the Constitution of the People's Republic of China and the Basic Law of the HKSAR, and are underpinned by the rule of law and an independent judiciary. The provisions of the ICCPR as applied to the HKSAR have already been incorporated into local law by the Hong Kong Bill of Rights Ordinance. Both the Central People's Government and the HKSAR Government are determined to make "one country, two systems" a continued success.

APEC holds Workshop on Promoting Energy Efficient, Resilient and Green Data Centres in Hong Kong via video conferencing

The Asia-Pacific Economic Cooperation (APEC) Workshop on Promoting Energy Efficient, Resilient and Green Data Centres was held in Hong Kong via video conferencing on June 28 and 29.

Delivering the opening remarks, the Secretary for the Environment, Mr Wong Kam-sing, noted that the HKSAR Government published last year Hong Kong's Climate Action Plan 2050, which mapped out Hong Kong's decarbonisation strategies and targets, as well as the climate adaptation and resilience measures.

More than 100 delegates and experts from six APEC member economies attended the workshop to exchange views on the best practices, challenges and the application of innovative technology in data centres.

HKSAR Government condemns European Parliament resolution

The HKSAR Government on July 8 condemned the European Parliament resolution of July 7 for making malicious allegations and defaming the rule of law in Hong Kong and the Hong Kong National Security Law, which transformed Hong Kong from chaos to order.

A spokesman for the Government said that the National Security Law has stopped chaos and restored order in Hong Kong, ensuring the smooth and continuous implementation of the "one country, two systems" principle and the long-term prosperity and stability of Hong Kong.

The spokesman also stressed that the European Parliament's remarks on the Chief Executive Election held after the HKSAR's electoral system had been improved were made arbitrarily, oblivious of the fact that democracy has taken a quantum leap forward in the HKSAR since its return to the motherland in July 1997. Moreover, the improved electoral system has also boosted the representativeness of the Legislative Council by optimising the composition of its members.

The spokesman added that the development of democracy in the HKSAR must be consistent with its constitutional order under the Constitution and the Basic Law and the "one country, two systems" principle, as well as with the political, economic, social, cultural and historical circumstances of the HKSAR. Improving the electoral system, ensuring "patriots administering Hong Kong" and safeguarding the overall interests of society are conducive to the stable development of Hong Kong's democracy.

Hong Kong residents born in 1992, 1993, 1994 or 1995 should apply for new smart identity cards from July 25 to October 6

The Immigration Department (ImmD) of the HKSAR Government announced on July 8 that Hong Kong residents born in 1992, 1993, 1994 or 1995 and holding the old form of smart identity card should bring along their identity cards and apply for new smart identity cards in person at a Smart Identity Card Replacement Centre (SIDCC) from July 25 to October 6.

The Territory-wide Identity Card Replacement Exercise covers all Hong Kong residents, who should apply for new smart identity cards in person at the SIDCCs during specified periods, whether they are permanent residents or non-permanent residents who are permitted to take up employment, make investment, reside or study in Hong Kong.

To avoid the gathering of crowds, the ImmD appeals to applicants to make appointments via the ImmD mobile application, the Internet (www.gov.hk/newicbooking), or the 24-hour telephone booking hotline 2121 1234.

Import of poultry meat and products from La Jacques-Cartier Regional County Municipality of Quebec Province in Canada suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on July 11 that in view of a notification from the World Organisation for Animal Health about an outbreak of highly pathogenic H5N1 avian influenza in La Jacques-Cartier Regional County Municipality of Quebec Province in Canada, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the area with immediate effect to protect public health in Hong Kong.

A CFS spokesman said that according to the Census and Statistics Department, Hong Kong imported about 4 tonnes of frozen poultry meat from Canada in the first three months of this year.
