All travelers who are fully vaccinated can board a flight for Hong Kong. They must hold a negative result of a polymerase chain reaction (PCR)-based nucleic acid test taken within 48 hours before boarding as well as a confirmation of a room reservation at a designated quarantine hotel (DQH) for at least seven nights. Pre-departure PCR-based nucleic acid tests are not required for travellers transferring or transiting in Hong Kong or inbound children aged below three.

In addition, starting from July 28, all persons boarding flights to Hong Kong are required to complete the online electronic "Health & Quarantine Information Declaration" (<u>https://www.chp.gov.hk/hdf/</u>) and obtain a QR code in advance. The code is valid for 96 hours and should be presented at check-in for verification by the airlines. <u>https://www.info.gov.hk/gia/general/202207/24/P2022072400400.htm</u>

Government trials upgraded electronic health declaration system to enhance arrival quarantine procedures

The HKSAR Government announced on July 24 the implementation of an upgraded electronic health declaration system on a trial basis starting from 0.00am on July 28 (Hong Kong Time), requiring inbound persons to complete the online electronic health declaration of the Department of Health and obtain a QR code before boarding their flights to Hong Kong. The launch of the upgraded electronic health declaration system will facilitate the Government's progressive enhancements to the electronic checking and processing of arrival quarantine procedures, thereby streamlining the process.

The health declaration QR code generated after completion of the declaration (which can be a downloadable version of the QR code, a screen shot or a printout) must be presented at check-in for verification by the airlines. The health declaration QR code will be valid for 96 hours.

In addition, with an increasing number of people arriving at Hong Kong from overseas, the demand for point-to-point transport services from Hong Kong International Airport (HKIA) to DQHs keeps rising. The HKSAR Government has enhanced the existing free point-to-point transport services for inbound persons, and also introduced new options of self-paid transport services. To use the self-paid DQH taxi service, passengers will have to pay the metered fares and any additional charges applicable, e.g. tunnel tolls and luggage fees.

DQH taxis operate from 8am to 2am daily. Inbound persons who opt to go to DQHs by taxis at their own expense should inform the staff at the Arrival Hall after completing immigration procedures and baggage claim. They should go to the designated area for waiting and boarding DQH taxis as instructed.

Government extends existing social distancing measures

The HKSAR Government announced on July 26 the gazettal of the extension of existing social distancing measures in accordance with the public health emergency regulations under the Prevention and Control of Disease Ordinance. The measures will be effective from July 28 to August 10.

The number of daily new cases in Hong Kong remains high at four-digit figures with an on-going rising trend. Balancing the needs for containing the epidemic and allowing social and economic activities, the Government decided to maintain the existing social distancing measures for the next 14-day cycle without making any relaxation.

Relevant measures include allowing all catering premises and scheduled premises to continue to operate subject to strict compliance with the requirements including use of the Vaccine Pass and "LeaveHomeSafe". Other requirements, such as mask-wearing for citizens in transport carriers and specified public places, as well as prohibition of group gatherings in public places, also remain in force.

The HKSAR Government on July 25 launched a public consultation for the Chief Executive's 2022 Policy Address. The Chief Executive, Mr John Lee, will deliver his first Policy Address on October 19.

Mr Lee stressed that he and his team are pleased to start a new chapter for Hong Kong with the fellow citizens. He advocated a people-based governing belief, while pursuing a



result-oriented approach to serve members of the public in a pragmatic manner. He earnestly invite members of the public to give views on the 2022 Policy Address.

The Government will conduct about 30 consultation sessions to listen to views and suggestions of the Legislative Council Members, representatives of various sectors and members of the public. HKSAR Government vehemently objects to United States Trafficking in Persons Report 2022

The HKSAR Government on July 20 vehemently objects to the biased and unfair assessment of the United States Trafficking in Persons Report 2022 (Report) of the Department of State of the United States (US).

A Government spokesman remarked that trafficking in persons (TIP) is never a prevalent problem in Hong Kong and there has never been any sign that Hong Kong is being actively used by syndicates as a destination or transit point for TIP.

The HKSAR Government has all along been making proactive and multi-pronged efforts in the fight against TIP, and injected an enormous amount of resources to combat TIP and enhance the protection and well-being of foreign domestic helpers in Hong Kong.

The spokesman stressed that the HKSAR Government, as a responsible member of the international community, will continue its firm commitment to combatting TIP and contributing to the global efforts for this important cause.

Immigration Department calls on members of public to apply for HKSAR passports early

The Immigration Department (ImmD) of the HKSAR Government reminded members of the public on July 22 to check the validity of their HKSAR passports in advance and arrange for renewal of their expired or expiring passports as early as possible to prevent any delay in outbound travel in the future.

The ImmD has introduced the HKSAR Passport Mobile Application Stations, which are promotional vehicles that will travel around all 18 districts throughout Hong Kong until early September to call on members of the public to arrange for renewal of an HKSAR passport early, and assist members of the public to apply for an HKSAR passport online.

The ImmD encouraged members of the public to submit their HKSAR passport applications through the Internet or the ImmD Mobile Application, or at Travel Document Submission Kiosks at the Immigration Headquarters in Wan Chai and the seven Immigration branch offices in a self-service manner.

At present, 168 countries and territories have granted visa-free access or visa-on-arrival to HKSAR passport holders. Some places require visitors to have a passport with validity of at least six months.

Two Hong Kong teams excel at international mathematical and physics Olympiads

Two teams of students representing Hong Kong achieved remarkable results in the 63rd International Mathematical Olympiad (IMO 2022) and the 52nd International Physics Olympiad (IPhO 2022) respectively. Due to the COVID-19 epidemic, Hong Kong teams participated in the competitions and activities via online mode.

The IMO 2022, hosted by Norway, was held from July 6 to 16, with the participation of 589 students from 104 countries or regions. The Hong Kong team won one gold medal, three silver medals, one bronze medal and one honourable mention.

The IPhO 2022, organised by Switzerland, was held from July 10 to 17. A total of 366 students from 76 countries or regions competed for the medals. The Hong Kong team won four silver medals and one bronze medal.
