The boarding requirements and quarantine arrangements for inbound persons from overseas places or Taiwan for Hong Kong are as follows:

- A declaration of the negative result of a self-arranged rapid antigen test (RAT) conducted within 24 hours prior to the scheduled time of departure should be made via the online Health & Quarantine Information Declaration of the Department of Health.
- Boarding requirement of having completed vaccination for Hong Kong residents are lifted. Non-Hong Kong residents aged 12 or above will still be required to be fully vaccinated or have obtained a medical exemption certificate before they are allowed to board a flight for Hong Kong.
- "Test-and-go" arrangement is implemented at the Hong Kong International Airport. Inbound persons can take public transport or self-arranged transport to return to their home or their hotel of choice.
- No compulsory quarantine are required. There are three days of medical surveillance during which inbound persons are free to go out but are obliged to comply with Amber Code restrictions under the Vaccine Pass, followed by a four-day selfmonitoring period.
- Nucleic acid tests on Day 2, Day 4 and Day 6 are required upon arrival at Hong Kong, supplemented by daily RATs from Day 1 to Day 7.
- For inbound persons who are tested positive by nucleic acid tests or RATs, their Vaccine Pass will be converted to a Red Code. Their isolation arrangements will be aligned with that for local cases.

## Policy Address: Charting a Brighter Tomorrow for Hong Kong

The Chief Executive of the HKSAR, Mr John Lee, set out his vision for Hong Kong and outlined his initiatives for the city's development in the next five years through his inaugural Policy Address on October 19.

Mr Lee said the Policy Address, entitled "Charting a Brighter Tomorrow for Hong Kong", was a "Policy Address for Hong Kong citizens". In the next five years, he will lead the government team to unite and motivate all sectors of the community, and give full play to Hong Kong's fine traditions of inclusiveness, unity and respect for different viewpoints.

The Chief Executive stressed that the full and faithful implementation of the "One Country, Two Systems" principle would help to ensure Hong Kong's long-term prosperity and stability, while also safeguarding national sovereignty, security and development interests.

The Chief Executive also pledged to take a result-oriented approach to policy-making while also enhancing governance systems, capability and efficacy.

To create strong impetus for growth, the Chief Executive announced that he had set aside HK\$30 billion to establish a Co-Investment Fund aimed at attracting non-local enterprises to set up operations in Hong Kong.

He added that, to support the convention and exhibition industry, a new HK\$1.4 billion scheme would be launched next year to subsidise over 200 exhibitions to be staged in Hong Kong in three years.

Mr Lee conclude that "guided by the important speech delivered by President Xi on July 1 as the governance blueprint for the current-term Government, it is our hope to better serve our people and better develop Hong Kong, so that everyone can share the fruits of our achievements."

Mr Lee, used his maiden Policy Address to outline the HKSAR Government's strategies to compete for enterprises and talents to strengthen the city's competitiveness.

Mr Lee's initiatives include setting up an Office for Attracting Strategic Enterprises (OASES) and a Top Talent Pass Scheme as well as enhancing existing talent admission schemes. The OASES will be tasked with attracting high-potential and representative strategic enterprises from around the globe, particularly those from industries of strategic importance, such as life and health technology, artificial intelligence and data science, financial technology, and advanced manufacturing and new energy technology.

The Government will also waive the requirement of applying for an employment visa for more visitors participating in short-term activities in Hong Kong.

With innovation and technology (I&T) being a core development focus, the Government would enlarge the talent pool for the tech sector.

To be more proactive in reaching out to target talents and enterprises, the functions of Mainland Offices and overseas economic and trade offices of the Government would be expanded to include dedicated teams that would enhance promotion of Hong Kong in Mainland and overseas markets.

To expedite Hong Kong's progression into an East-meets-West centre for international cultural exchange, as set out in the National 14th Five-Year Plan, the Chief Executive highlighted the need to foster creative talents and attract leading lights in arts and culture from around the world to come to Hong Kong.

Furthermore, Mr Lee said that solving the housing problem in Hong Kong tops the agenda of the current-term Government. To fast-track housing and land supply, the Chief Executive has decided to set the key housing and land strategies, including the

introduction of Light Public Housing, boosting public housing production, and enhancing public-private partnership etc.

The Chief Executive also said that the HKSAR Government is determined to increase land supply to meet demand and build up land reserve. The Government would take a multi-pronged approach to cutting the time needed for land production.

Mr Lee also set out a four-pronged strategy for taking Hong Kong's I&T development to the next level.

The key areas include enhancing the city's I&T ecosystem, enlarging the pool of local and non-local I&T talents, developing Hong Kong into a smart city and proactively integrating into the overall development of the country.

In addition, in his inaugural Policy Address, Mr Lee said the HKSAR Government would duly address the people's aspirations for a better life by building a more harmonious and stable Hong Kong that better supports the elderly and the disadvantaged as well as creating a better living environment for all. Mr Lee set out his plans for a revamped healthcare system focused on prevention, as well as expanding the role of Chinese medicine.

To enhance Hong Kong's vibrancy, the Government will also map out a 10-year development blueprint for sports and recreation facilities, providing about 30 diversified facilities by phases.

Moreover, in order to build a liveable Hong Kong, the Government would strive to reduce the total carbon emissions by 50 per cent before 2035 (from the level of 2005) to achieve the goal of carbon neutrality before 2050.

## HKSAR Government expresses strong disapproval of remarks by spokesperson for United Nations High Commissioner for Human Rights about court case under **National Security Law**

The HKSAR Government on October 13 expressed strong disapproval of the recent remarks by a spokesperson for the United Nations High Commissioner for Human Rights about the Hong Kong court's reasons for sentence delivered on October 8 in regard to a case of conspiracy to incite the commission by other persons of the offence of subversion under the Law of the People's Republic of China on Safeguarding National Security in the HKSAR (National Security Law).

The HKSAR Government spokesperson stressed that human rights and the provisions of the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights are enshrined in the National Security Law, with an emphasis placed on the fact that principles of human rights protection must be observed when safeguarding national security.

He stressed that the National Security Law has achieved the intended effect, and has swiftly and effectively restored stability and security.

## Import of poultry meat and products from areas in Canada suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on October 5, October 11 and October 19 respectively that in view of notifications from the World Organisation for Animal Health (OIE) about outbreaks of highly pathogenic H5N1 avian influenza in the below areas in Canada, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the areas with immediate effect to protect public health in Hong Kong:
