In response to the local government's appeal for concerted efforts to contain the spread of COVID-19, the Hong Kong Economic and Trade Office (Toronto) (HKETO) is closed temporarily. You may reach us via the following channels:

The boarding requirements and quarantine arrangements for inbound persons from overseas places or Taiwan for Hong Kong are as follows:

• A declaration of the negative result of a self-arranged rapid antigen test (RAT) conducted within 24 hours prior to the scheduled time of departure should be made via the online Health & Quarantine Information Declaration of the Department of Health.

• Boarding requirement of having completed vaccination for Hong Kong residents are lifted. Non-Hong Kong residents aged 12 or above will still be required to be fully vaccinated or have obtained a medical exemption certificate before they are allowed to board a flight for Hong Kong.

• "Test-and-go" arrangement is implemented at the Hong Kong International Airport. Inbound persons can take public transport or self-arranged transport to return to their home or their hotel of choice.

• No compulsory quarantine are required. There are three days of medical surveillance during which inbound persons are free to go out but are obliged to comply with Amber Code restrictions under the Vaccine Pass, followed by a four-day self-monitoring period.

• Nucleic acid tests on Day 2, Day 4 and Day 6 are required upon arrival at Hong Kong, supplemented by daily RATs from Day 1 to Day 7.

• For inbound persons who are tested positive by nucleic acid tests or RATs, their Vaccine Pass will be converted to a Red Code. Their isolation arrangements will be aligned with that for local cases.

HKETO Director visits Calgary

Director of the HKETO, Ms Emily Mo, visited Calgary from October 27 to 28 to strengthen Hong Kong's relations with the Province of Alberta and to promote Hong Kong as the ideal platform for Canadian companies to tap on the markets in Asia and beyond.

On October 27, Ms Mo held a lunch meeting with Vice President, Business Development of Fluid Energy Group Ltd. and a former Canadian diplomat, Mr Ron Hoffmann, to exchange views on strengthening trade relations between Alberta and Hong Kong. Ms Mo also had a meeting with the President and Chief Executive Officer of Calgary Chamber of Commerce, Ms Deborah Yedlin, on trades and business promotion between the two cities, particularly on the information and technology, clean technology, clean energy and healthcare sectors.

In the evening, Ms Mo attended the HKCBA (Calgary)'s networking reception entitled "A New Era: Succeeding in Asia and Beyond through Hong Kong" and delivered a speech. She updated the attendees that Hong Kong has been maintaining its status as the top international financial market and continued to be the freest economy in the world.

HKETO supports Canadian hybrid mission to join the ASGH 2022

Director of the HKETO, Ms Emily Mo, joined the "Canadian Hybrid Mission to Asia Summit on Global Health (ASGH)" pre-mission networking meeting jointly organised by HKETO, HKTDC, Invest Hong Kong (Canada) and the HKCBA on October 26.

The meeting aimed to provide Canadian delegates with an overview of the ASGH programme, and how they can take advantage of this trade mission to exchange insights, explore opportunities and collaborate with stakeholders from around the world through the Hong Kong platform. Themed "Charting a New Course in Healthcare through



Collaboration", this second Asia Summit on Global Health will be staged in Hong Kong from November 10 to 11.

In delivering the opening remarks, Ms Mo shared with participants that Hong Kong has a vibrant ecosystem for start-ups, including those focusing on health-related areas. Hong Kong is now Asia's largest and the world's second-largest fundraising hub for biotech companies.

Ms Mo also highlighted that Hong Kong has a robust Intellectual Property protection regime and about one third of the patents filings from local and overseas applications are in the fields of biotechnology, pharmaceuticals and media technology.

Early Cretaceous rhyolitic columnar rock formation of Hong Kong Geopark selected as one of the First 100 IUGS Geological Heritage Sites

The Agriculture, Fisheries and Conservation Department (AFCD) of the HKSAR Government announced on October 22 that the Early Cretaceous rhyolitic columnar rock formation (hexagonal volcanic rock columns) located in Hong Kong UNESCO Global Geopark had been selected as one of the First 100 International Union of Geological Sciences (IUGS) Geological Heritage Sites.

A spokesman for the AFCD said that the Early Cretaceous rhyolitic columnar rock formation visible along the coast and on numerous islands in Sai Kung is named the High Island Formation. The formation comprises a great number of columns, which are large, well preserved and widely distributed, making it a globally rare and iconic geological wonder. The selection of the High Island Formation as one of the First 100 IUGS Geological Heritage Sites recognises its international importance.

Import of poultry meat and products from areas in Canada and US suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on October 24 and November 2 respectively that in view of notifications from the World Organisation for Animal Health about outbreaks of highly pathogenic H5N1 avian influenza in the below areas, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the areas with immediate effect to protect public health in Hong Kong.
