#### **SPECIAL NOTICE**

The pre-departure testing requirement for inbound persons (aged three or above on the date of arrival at Hong Kong) from overseas places or Taiwan is in effect. They are required to conduct a rapid antigen test (RAT) within 24 hours, or undergo a nucleic acid test within 48 hours, prior to the scheduled time of flight departure, and obtain a negative result for entering Hong Kong. Upon receiving the test results, relevant persons should keep the photos showing the test results or the test report for 90 days for presentation for checking on request by Government personnel. They may also voluntarily declare the test result via the Department of Health's electronic health declaration form.

Inbound persons are advised to conduct daily RAT until Day 5 after their arrival at Hong Kong.

## **HKETO Director joins webinar to promote ICT opportunities in Hong Kong**

Director of the HKETO, Ms Emily Mo, joined the "Window of Opportunity in the ICT Sector in Hong Kong for Canadian Companies" webinar co-hosted by the HKETO, Hong Kong Trade Development Council (Toronto), Invest Hong Kong (Canada) and Hong Kong-Canada Business Association (Toronto Section) on February 7.

# Government lifts vaccination requirement for non-Hong Kong residents arriving from overseas places

The HKSAR Government announced on February 3 that the requirement for non-Hong Kong residents to be fully vaccinated for coming to Hong Kong from overseas places would be lifted starting February 6. The pre-departure testing requirement for inbound persons from overseas places or Taiwan will be maintained for the time being.

## Full resumption of normal travel between Hong Kong and Mainland

The HKSAR Government on February 3 announced that normal travel between Hong Kong and the Mainland would fully resume starting February 6. The arrangements concerned include opening up all boundary control points without imposing any prescribed daily numbers of people thereon; cancelling the pre-departure nucleic acid test requirement; and enabling cross-boundary students to resume face-to-face classes in an orderly manner.

All pre-departure testing requirements for travelling between the two places have been lifted. However, for persons travelling from Hong Kong to the Mainland (except those aged 3 and below), if they have stayed in overseas places or Taiwan on the day of departing Hong Kong for the Mainland or during the seven days before that day, they are still required to conduct a nucleic acid test within 48 hours prior to departure and obtain a negative result as per the Mainland's requirements.

## Hong Kong Customs takes strict enforcement action to control cannabidiol (CBD)

The new legislative control of cannabidiol (CBD) has come into effect on February 1. CBD will be under the same strict control as other dangerous drugs under the Dangerous Drugs Ordinance (DDO) from that day. With the commencement of the new regulation, Hong Kong Customs will take vigorous enforcement action to fiercely combat the related drug trafficking activities.

Under the DDO, trafficking (including importing and exporting) and illicit manufacturing of CBD is liable to a maximum penalty of a fine of HK\$5 million and life imprisonment. Possession and consumption of CBD in contravention of the DDO will be subject to a maximum penalty of a fine of HK\$1 million and imprisonment of seven years.

Hong Kong Customs reminds members of the public not to bring any cannabis products or products containing CBD into Hong Kong. To avoid breaching the law inadvertently, they should also refrain from buying any CBD products, and pay attention to whether the products' packaging and labels contain wordings of CBD or tetrahydrocannabinol (THC) when making any purchase.

# Application date for identity card replacement at Smart Identity Card Replacement Centres extends to March 3

Given that a number of members of the public have returned to Hong Kong for identity card replacement recently, the Immigration Department (ImmD) of the HKSAR Government announced on January 26 that the last application date for replacement of new smart identity cards at the Smart Identity Card Replacement Centres (SIDCCs) would be extended to March 3, 2023.

Hong Kong residents who are unable to have their identity cards replaced on or before March 3, 2023, due to absence from Hong Kong can apply at a Registration of Persons Office within 30 days upon their future return to Hong Kong and need not rush back to Hong Kong for identity card replacement. If they return to Hong Kong and stay in Hong Kong for less than 30 days, they would not violate the relevant law for not having their identity cards replaced during that time.
