Network of Family Office Service Providers launched to promote Hong Kong as preferred destination for global family offices

InvestHK announced on June 12 the launch of the Network of Family Office Service Providers (the Network), a platform specially designed to help promote Hong Kong as a preferred destination of choice for global family offices. Over 100 representatives from a

wide array of family office service providers participated in the launch, under the witness of key representatives from regulators and industry associations.

The Network aims to nurture the ecosystem that continues to support local and global family offices as they set up or expand in the Hong Kong market. It also provides a two-way channel for the Hong Kong Special Administrative Region (HKSAR) Government to brief the industry on the latest development and provide opportunities for family offices in Hong Kong, and to mobilise their networks around the world to advocate opportunities in Hong Kong for family offices.

The HKSAR Government is actively pursuing various initiatives to create a conducive and competitive environment for the businesses of global family offices and asset owners to thrive and propel the family office ecosystem in Hong Kong. Some of the new initiatives also include a new Capital Investment Entrant Scheme, tax concessions, a new Hong Kong Academy for Wealth Legacy, establishing art storage facilities at the airport and developing Hong Kong as a philanthropic centre.

Government establishes Northern Metropolis Co-ordination Office

The Development Bureau of the HKSAR Government on June 12 announced the establishment of the Northern Metropolis Co-ordination Office (NMCO) to co-ordinate, champion and drive the development of the Northern Metropolis.

With the theme of "International Innovation and Technology New City", the Northern Metropolis integrates quality living, industries, and culture and leisure. It is a new engine for Hong Kong to scale new heights, and an important platform to promote high-quality economic co-operation between Hong Kong and the Guangdong-Hong Kong-Macao Greater Bay Area and for Hong Kong to integrate into the overall national development.

The Northern Metropolis project covers aspects such as land development, housing supply, transport infrastructure, ecological conservation, development of industries, and government and community facilities.

HKSAR Government's Institutional Green Bonds Offering

The HKSAR Government on June 1 announced the successful offering of close to US\$6 billion worth of green bonds (the Green Bonds), denominated in US dollars (USD), euro (EUR) and Renminbi (RMB), under the Government Green Bond Programme.

The offering included different types of currencies and tenors, which continued to attract a wide spectrum of investors and was well received, with close to US\$30 billion equivalent in orders. In particular, the RMB tranches were expanded from a combined RMB10 billion from the January 2023 issuance to RMB15 billion this time, with the additional issuance of a new 10-year RMB tranche.

The Green Bonds were settled on June 7 and listed on the Hong Kong Stock Exchange and the London Stock Exchange. The Green Bonds have been assigned credit ratings of AA+ by S&P Global Ratings and AA- by Fitch.

The launch of the HKD-RMB Dual Counter Model and the Dual Counter Market Making Programme is a significant step towards developing a diversified range of RMBdenominated products in Hong Kong. The initiatives will facilitate the use of the RMB in equity trading in Hong Kong and further expand the RMB investable universe, thereby reinforcing Hong Kong's role as the leading offshore RMB business hub.

Expanding civil service recruitment to undergraduate students in third year of study

In order to attract people with aspirations to serve the community to join the civil service, starting from this year, the HKSAR Government will expand the pool of eligible candidates for civil service jobs requiring an undergraduate degree to students advancing to their third year of undergraduate studies (in a four-year curriculum) in the new academic year

or those currently in their third year of undergraduate studies. Recommended candidates will be granted a conditional offer and will join the Government upon graduation.

This new initiative will be a win-win situation for young people, universities as well as the Government. Young people with aspirations to join the Government will be able to plan their careers early, focus on their studies and equip themselves after being offered a conditional appointment. Universities will be able to help more students interested in public services to plan ahead and better prepare themselves. The Government will be able to recruit talent as early as possible to infuse new blood into the civil service and build up a diverse talent pool.

In light of the new initiative, the Civil Service Bureau will adjust the arrangements of the relevant civil service recruitment examinations accordingly. The next round of the Common Recruitment Examination and the Basic Law and National Security Law Test (Degree/Professional Grades) is tentatively scheduled to be open for application in August (for examinations in Hong Kong) and September (for examinations outside Hong Kong) this year, while the Joint Recruitment Examination (for examinations in and outside Hong Kong) is tentatively scheduled to be open for application in September.
