FS unveils 2024-25 Budget

Unveiling his 2024-25 Budget on February 28, the Financial Secretary of the HKSAR, Mr Paul Chan, proposed a series of measures aimed at bolstering confidence and creating favourable conditions for recovery, including continuing to attract enterprises, capital and talent on all fronts, as well as providing assistance to small and medium-sized enterprises through various measures, such as extending the application period for the 80% and 90% Guarantee Products under the SME Financing Guarantee Scheme for two years.

For the property market, the Budget announced the immediate cancellation of all demandside management measures for residential properties. The Hong Kong Monetary Authority will also adjust the countercyclical, macroprudential measures for property mortgage loans and relevant supervisory policies pertinent to property lending, where appropriate.

The Budget also highlighted establishing Hong Kong as a premier destination for business and tourism through hosting more mega events and thematic annual conferences; and focusing on green development and the digital economy.

Regarding public finance, the HKSAR Government is implementing a comprehensive fiscal consolidation programme to achieve fiscal balance gradually and maintain fiscal reserves at a prudent level.

The Financial Secretary proposed a one-off reduction of profits tax, salaries tax and tax under personal assessment for the year of assessment 2023/24 by 100 per cent, subject to a ceiling of \$3,000 per case. On profits tax, tax deduction is proposed for expenses incurred in reinstating the condition of the leased premises to their original condition and to remove the time limit for claiming industrial and commercial building allowances commencing from the year of assessment 2024/25.

HKSARG welcomes EU's removal of Hong Kong from watchlist on tax co-operation

The Hong Kong Special Administrative Region (HKSAR) Government on February 20 welcomed the removal of Hong Kong from the European Union's watchlist on tax cooperation in recognition of Hong Kong's efforts in ensuring that its foreign-sourced income exemption (FSIE) regime is in full compliance with the EU's relevant requirements.

In response to the EU's inclusion of Hong Kong in its watchlist in 2021, the HKSAR Government introduced in January 2023 a new FSIE regime, under which multinational enterprise entities receiving foreign-sourced dividend, interest, income derived from the use of intellectual properties and disposal gain in relation to shares or equity interests in Hong Kong must satisfy the economic substance requirement to enjoy tax exemption.

The Secretary for Financial Services and the Treasury of the HKSAR Government, Mr Christopher Hui, said that Hong Kong has all along been supporting international cooperation in combating cross-border tax avoidance and will continue to comply with international tax standards while maintaining Hong Kong's tax competitiveness.

Al driverless technology company sets up international headquarters in Hong Kong

InvestHK announced on February 22 that UISEE has picked Hong Kong to set up its international headquarters as a springboard to global expansion. It will also establish a research and development (R&D) centre in the city focusing on applications for overseas developments.

The Beijing-founded company, which is a leading autonomous driving technologies company already with two R&D centres and multiple offices in Mainland China, started their first overseas driverless project with Hong Kong International Airport (HKIA) in 2019. To date, UISEE has provided more than 50 driverless cars to HKIA, completing more than 700 000 kilometres of real driverless operation.

Import of poultry meat and products from areas in Canada suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on February 20 that in view of a notification from the World Organisation for Animal Health about outbreaks of highly pathogenic H5N1 avian influenza in Drummond Regional County Municipality of Quebec Province and Essex County of Ontario Province in Canada, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the abovementioned areas with immediate effect to protect public health in Hong Kong.

A CFS spokesman said that according to the Census and Statistics Department, Hong Kong imported about 270 tonnes of frozen poultry meat from Canada last year.
