# HKETO Director promotes Hong Kong's strengths in medical and healthcare development

Director of the HKETO, Ms Emily Mo, briefed Canadian medical industry professionals on Hong Kong's strengths in healthcare infrastructure at a virtual meeting co-organised by the HKTDC and the HKCBA (Ottawa Section) on April 18.

In her opening remarks, Ms Mo introduced Hong Kong's efforts to transform the city into a hub of health and medical innovation, in which some Canadian research institutes and companies have already engaged in collaborative endeavors in research and development (R&D) in Hong Kong.

On a local front, Ms Mo noted that the Hospital Authority (HA) of Hong Kong has implemented a unified clinical management computer system, which helped facilitate clinical trial networks and big data research. The HA's plan to open the Cluster Clinical Research Support Office also underscored the city's dedication to streamlining and enhancing the clinical trial process.

Also speaking at the briefing was Dr Gladys Kwan, HA's Chief Manager of the Medical Grade. She introduced the HA's efforts in recruiting talents worldwide to join the medical work in Hong Kong.

At the meeting, the host also announced that a Canadian delegation with health professionals will visit Hong Kong and join the Asia Summit on Global Health and the Hong Kong International Medical and Healthcare Fair in May.

#### **HKIA Crowned World's Busiest Cargo Airport**

Hong Kong International Airport (HKIA) has been named once again the world's busiest cargo airport for 2023 in terms of total volume, according to the latest data released by Airports Council International on April 15. The airport handled 4.3 million tonnes of cargo during the year. It is the 13th time since 2010 that HKIA is named the busiest cargo airport in the world.

Airport Authority Hong Kong said that this accomplishment demonstrates HKIA's resilience, unparalleled efficiency and world-class cargo services. Air cargo is a key driver of the growth of Hong Kong's logistics industry and overall economic development.

In addition, to enhance connectivity with the GBA, HKIA has launched a novel cargo seaair transshipment operation which enables security screening, palletisation, cargo acceptance and other services to be completed upstream at the HKIA Dongguan

Logistics Park before the cargo is shipped to HKIA by sea for air transshipment to worldwide destinations. Conversely, a similar process is in place for international imports to the Mainland.

# Hong Kong delegation shines at 49th International Exhibition of Inventions of Geneva

The 49th International Exhibition of Inventions of Geneva was held from April 17 to 21 in Geneva, Switzerland. Hong Kong delegation was the largest ever, comprising close to 700 representatives from 40 organisations including universities, research and development centres, research laboratories, technology companies, government departments, and primary and secondary schools. The delegation has won a record high number of over 350 prizes, including six Special Awards, 28 Gold Medals with Congratulations of Jury and 114 Gold Medals.

Among the prizes, the Electrical and Mechanical Services Department of the HKSAR Government won seven gold medals, 10 silver medals and four bronze medals. In addition, the Information Systems Wing of the Hong Kong Police Force also garnered five Gold Medals and one Silver Medal in total with a theme of Reinventing of Public Safety, including a prestigious Gold Medal with the Congratulations of Jury.

The International Exhibition of Inventions of Geneva is one of the most significant global annual events on inventions. More than 1 000 inventions from nearly 40 countries and regions were evaluated by the international jury of specialists this year.
