APEC Finance Ministers' Meeting 2026 will be held in Hong Kong

China will be the host of the Asia-Pacific Economic Cooperation (APEC) in 2026. The Central Government announced on December 12 that the APEC Finance Ministers' Meeting (FMM) 2026 will be held in Hong Kong for the first time in October 2026.

Large-scale international aviation exhibition and conferences conclude in Hong Kong

Hong Kong marked a significant milestone in regional aviation by hosting two large-scale international exhibition and conferences, the Civil Air Navigation Services Organisation Asia Pacific Conference 2025 and the Airspace Asia Pacific 2025. Concluded on December 8 and 11 respectively, these two important international events demonstrated Hong Kong's status as an international aviation hub.

Themed "Seamless Asia Pacific Airspace - Aviation and Meteorology Integration" and "Shaping the Future of Asia Pacific's Skies", the exhibition and conferences featured multiple keynote sessions and panel discussions focusing on exploring the most significant challenges and opportunities in air traffic management. Topics covered the low-altitude economy, green aviation, Al and climate challenges, etc.

The events have brought together over 2 000 decision-makers from air navigation service providers, professionals, regulatory bodies, and innovative technology companies from around the world, and also attracted over 70 exhibitors presenting cutting-edge technologies in air traffic management, low-altitude traffic management, Al applications, and emerging aviation technologies.

Commencement dates of Eighth Term LegCo and 2026 legislative session

The HKSAR Government announced on December 8 that the eighth Legislative Council of the HKSAR has been successfully formed, as all 90 seats have been filled following the smooth completion of the election on December 7.

In accordance with section 4(3) of the Legislative Council Ordinance, the Chief Executive in Council has specified January 1, 2026, as the commencement date of the Eighth Term Legislative Council of the HKSAR. The 2026 legislative session will begin on the first Wednesday after the President of the Legislative Council of the HKSAR is elected.

The Chinese Medicine Hospital of Hong Kong commences operations

The Chinese Medicine Hospital of Hong Kong (CMHHK) has commenced operations in phases on December 11, offering outpatient and day-patient services, fully launching six specialised Chinese medicine services, along with 12 special disease programmes in the first year.

In response to the keen public demand for government-subsidised outpatient services, the CMHHK will increase the quota for members of the public to book government-subsidised general outpatient services in the first month.

It marks a significant milestone in the development of Chinese medicine in Hong Kong, signifying the progression of Hong Kong's Chinese medicine to go beyond primary healthcare and play a part in secondary and tertiary healthcare services.

Import of poultry meat and products from areas in Canada suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on December 9 that in view of notification from the World Organisation for Animal Health about outbreak of highly pathogenic H5N1 avian influenza in the Columbia-Shuswap Regional District of the Province of British Columbia in Canada, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the area with immediate effect to protect public health in Hong Kong. In the first nine months of 2025, no poultry meat or eggs were imported into Hong Kong from Canada.
